#### **CEREMONIAL ACTIVITIES**

3.1 Honouring former Alderman William McCulloch and his Appointment to the Hamilton Veterans Committee as Honorary Chair

Members of Council paid tribute to former Alderman William (Bill) McCulloch who has been appointed Honorary Chair of the Hamilton Veterans Committee.

Mr. McCulloch was elected as City Alderman and Regional Councillor representing Ward 2 for 30 years from 1964 to 1966 and then again from 1968 to 1997.

His numerous accomplishments and contributions include, sitting on the Police Services Board, earning a Bachelor's Degree with Honours from McMaster, significant contributions to the Hamilton Arts community, and managing and owning a variety of restaurants and theatres.

His passion for Hamilton's history lead to his roles as a founding member of both the Local Architectural Conservation Advisory Board (now Municipal Heritage Committee), the Hamilton Historical Board, and the Joint Planning Subcommittee.

In addition, Mr. McCulloch played a vital role in the development of Hamilton's Civic Museums including the restoration of Dundurn Castle, the preservation of the Hamilton Military Museum and the protection of the sunken warships, Hamilton and Scourge. He also served as Co-chair of the City's 50<sup>th</sup> and 60<sup>th</sup> VE Day anniversary commemoration committees.

He served in the Royal Canadian Navy during the Korean War, and was later attached to the U.S. Navy, and later serving on the Canadian light cruiser the Quebec.

He retired as a Lieutenant Commander and in 2012, and was presented with the Queen's Diamond Jubilee Medal for his work with the Hamilton Veterans Committee and the City of Hamilton.

The designation that we are honouring today is of particular significance because in his role as Chairman of the Decoration and Memorial Day Committee, he initiated the Hamilton Veterans Committee back in 1972.

Mr. McCulloch was honoured for his accomplishments and his designation as Honorary Chair of the Hamilton Veterans Committee for life.

# 7.1 Maintain Hydro One as a Wholly Owned Public Asset for the Benefit of All Ontarians

#### (Merulla/Collins)

WHEREAS the public electricity system in Ontario is a critical asset to the economy;

WHEREAS the public electricity system generates significant revenue for municipal and provincial governments and gives Ontario a competitive advantage;

WHEREAS local control and decision making is important to meet the needs of our communities and residents;

WHEREAS local electricity distribution companies provide a source of stable and predictable revenue to our communities;

WHEREAS some Ontario municipalities have examined possible sales or mergers of their local distribution companies, and have decided not to sell to Hydro One or the private sector; and,

WHEREAS the privatization, partial or whole, of electricity has led to higher rates and less control:

#### THEREFORE BE IT RESOLVED:

- (a) That the City of Hamilton call on the provincial government to:
  - (i) Stop the sale of any part of Hydro One, and maintain Hydro One as a wholly owned public asset for the benefit of all Ontarians;
  - (ii) Strengthen Hydro One by investing in the next generation of workers and upgrading aging infrastructure; and,
  - (iii) Respect the autonomy and local decision-making powers of local distribution companies by not forcing these companies into mergers or sales;
- (b) That the City of Hamilton circulate this resolution for support to the Association of Municipalities of Ontario (AMO) and the Electricity Distributors Association and the Large Urban Mayors Caucus of Ontario (LUMCO).

# 7.4 Amendments to the Hamilton Port Authority – City of Hamilton Liaison Committee

#### (Eisenberger/Whitehead)

WHEREAS, in 2000, the City of Hamilton and the Hamilton Harbour Commissioners (HHC) entered into an Agreement to settle existing disputes, provide a framework and vision for future harbour developments, and assist and guide the Port Authority in a spirit of goodwill and understanding and without need for recourse litigation;

WHEREAS, the Agreement is binding upon the HHC's successor, the Hamilton Port Authority;

WHEREAS, the City and the HHC adopted a Charter, which forms Schedule 1 to the Agreement, which enshrines these objectives;

WHEREAS, enshrined within the Charter is a mutual commitment to communicate on matters of interest to both parties, and consult on physical developments and management policies affecting the other, at regular intervals and on a continuous on-going basis, at both a senior administrative level and a Board – Council level;

WHEREAS, both organizations committed to receiving reports and providing direction as deemed appropriate on issues requiring action to support joint interests;

WHEREAS, both organizations committed to a framework for dispute resolution, which is laid out in the Charter, to avert future Court action;

WHEREAS, the Charter set out an itemized list of areas of mutual interest, which invoke a comprehensive approach to virtually all activity, development and sustainability of the Port and a commitment to public consultation on significant decision relating to Port and adjacent City lands;

WHEREAS, the Hamilton Port Authority-City of Hamilton Liaison Committee had a mandate for the Council Term 2010-2014, which related specifically to Pier 8; and.

WHEREAS, in the interest of ensuring that the opportunities currently on the horizon are embraced, and to ensure more robust consultation and cooperation, it is appropriate to now make a minor addition to the Terms of Reference:

7.5 Support for the Canadian Steel Industry by opposing the request for British Columbia to be exempted from Anti-dumping (AD) and Countervailing Duties (CVD) on Illegally Imported Rebar

#### (Duvall/Merulla)

WHEREAS, in 2014, Canada's rebar producers initiated a complaint under the *Special Import Measures Act* against illegally dumped and subsidized rebar from off-shore producers;

WHEREAS, the Canadian International Trade Tribunal (CITT) determined in January 2015 that imports of rebar from China, South Korea and Turkey would injure Canadian producers; and,

WHEREAS, Canadian companies (producing over 500 thousand tonnes of rebar per annum) can demonstrate that there is **NO** shortage of fairly-traded, competitively–priced rebar available in British Columbia from Canadian and other foreign sources;

#### THEREFORE BE IT RESOLVED:

That the City of Hamilton support the actions of the Canadian International Trade Tribunal confirming that the importation of rebar from China, South Korea, and Turkey will in fact injure Canadian producers such as Arcelor Mittal Dofasco that represent an integral part of the domestic steel industry and are a significant employer in the City of Hamilton and throughout Canada.
