

## **CITY OF HAMILTON**

### **BY-LAW NO. 15-**

#### **To Amend By-law No. 01-218, as amended, Being a By-law To Regulate On-Street Parking**

**WHEREAS** *Section 11(1)1 of the Municipal Act, S.O. 2001, Chapter 25*, as amended, confers upon the councils of all municipalities the power to enact by-laws for regulating parking and traffic on highways subject to the *Highway Traffic Act*;

**AND WHEREAS** on the 18th day of September, 2001, the Council of the City of Hamilton enacted By-law No. 01-218 to regulate on-street parking;

**AND WHEREAS** it is necessary to amend By-law No. 01-218, as amended.

**NOW THEREFORE** the Council of the City of Hamilton enacts as follows:

1. Schedule 6 (Time Limit Parking) of By-law No. 01-218, as amended, is hereby further amended by adding to Section "C" thereof the following item, namely:

"Griffin	North	Franklin to Mill	2 hr	8 am – 5 pm	Mon – Fri"

2. Schedule 8 (No Parking Zones) of By-law No. 01-218, as amended, is hereby further amended by adding to Section "E" thereof the following items, namely:

"Albright	North	from westerly end to 81.6m easterly	Anytime

Quinlan	Both	Throughout cul-de-sac	December 1 <sup>st</sup> to" March 31 <sup>st</sup>

3. Schedule 12 (Permit Parking Zones) of By-law No. 01-218, as amended, is hereby further amended by deleting from Section "E" thereof the following items, namely:

"Belmont	East	from 17.9m south of Campbell to 5.7m southerly	Anytime
Garside	East	from 7.6m north of Roxborough to 5.1m northerly	Anytime
Garside	West	from 7.3m north of Roxborough to 4.9m northerly	Anytime
Paling	East	from 30.3m north of Vansitmart to 6.5m northerly	Anytime"

and by adding to Section "E" thereof the following items, namely:

"Avondale	West	from 65.2m south of Beechwood to 6m southerly	Anytime
Avondale	East	from 69.9m south of Beechwood to 5.4m southerly	Anytime
Cope	West	from 145.6m north of Vansitmart to 6m northerly	Anytime
Paling	East	from 28m north of Vansitmart to 6m northerly	Anytime
Weir	East	from 25.9m south of the extended south curb line of Maple to 6m southerly	January 1 <sup>st</sup> to June 30 <sup>th</sup>

4. Schedule 20 (School Bus Loading Zones) of By-law No. 01-218, as amended, is hereby further amended by deleting from Section "E" thereof the following item, namely:

"Albright	South	67 feet	175 feet east of Harrisford	7:00 a.m. – 6:00 p.m." Monday to Saturday

5. Subject to the amendments made in this By-law, in all other respects, By-law No. 01-218, including all Schedules thereto, as amended, is hereby confirmed unchanged.
6. This By-law shall come into force and take effect on the date of its passing and enactment.
