(i) Delegation from Robyn Lloyd respecting Allowing Larger-Sized Dogs on the HSR (Item 6.1)

Ms. Robyn Lloyd addressed the Committee respecting Allowing Larger-Sized Dogs on the HSR.

Ms. Lloyd's presentation included, but was not limited to, the following:

 Ms. Lloyd understands there are concerns with allowing dogs on transit. The concerns include:

- Fear of Dogs by other passengers
- Allergies
- Dealing with rush hour and overcrowding
- Dogs urinating and defecating on buses
- Ms. Lloyd said concerns about the misbehavior of dogs on the transit system can be helped by allowing the driver to have the discretion to remove such animals. Fines could also be considered for pet owners violating rules.
- Some individuals are concerned about health issues that dogs may have. This can be alleviated by working with veterinarians to possibly set up a health/wellness card.
- Other municipalities, including the City of Toronto, have successfully allowed dogs on their transit system and they provide a good example on how to implement this.
- Pet ownership is growing and it is an \$8.9 billion industry worldwide.
