**THE FACILITY NAMING SUB-COMMITTEE PRESENTS REPORT 15-002 AND  
RESPECTFULLY RECOMMENDS:**

- 1. Naming of "Corporal Nathan Cirillo Leash Free Area" (PW15061) (Ward 12) (Item 8.1)**
  - (a) That the stormwater management pond located at 799 Golf Links Road, Ancaster which is used as a leash free dog park, be named the "Corporal Nathan Cirillo Leash Free Area" as this meets the guidelines set out in the City of Hamilton Municipal Property and Building Naming Policy;
  - (b) That the City Solicitor be authorized and directed to prepare the appropriate amendment to By-law 12-031, a By-law "For Responsible Animal Ownership in the City of Hamilton", to include the "Corporal Nathan Cirillo Leash Free Area" as a leash free location for dogs; in a form satisfactory to the City Solicitor.

**(i) Revisions to the City of Hamilton Municipal Property and Building Naming Policy (PW05124(a)) (City Wide) (Outstanding Business List Item) (Item 7.1)**

The Chair suggested that a formal presentation from Adrienne Kupchanko, Policy/Program Analyst, would not be required.

The Committee sought clarification on the process for a Commemorative Bench in Schwenger Park. Staff advised that an application to the Commemorative Bench Program is required, and that the request would not come before the Facility Naming Sub-Committee.

The Committee sought clarification on elected officials being eligible for naming opportunities. Staff advised that elected officials must be retired from politics, or deceased before becoming eligible for naming opportunities.

That Report PW05124(a) respecting the Revisions to the City of Hamilton Municipal Property and Building Naming Policy be referred back to staff to provide the Facility Naming Sub-Committee with clarification on the following matters:

- (i) Municipal Property and Parkland Name expiration;

- (ii) Naming of Municipal Property or Building related to geographic area of neighbourhood;
- (iii) Process for removal of current name of Municipal Property or Building.

**(iii) Recognition of Frank Cook, former General Manager of the Hamilton Street Railway (Added Item 8.4)**

Staff was directed to investigate the process for recognizing Frank Cooke, former General Manager of the Hamilton Street Railway, at the proposed location for the Light Rail Transit (LRT) transportation hub.
