1. Neighbour 2 Neighbour Community Food Centre (BOH15030)(Item 8.1)

#### (Whitehead/Green)

- (a) That the City of Hamilton ("City") provide a one-time grant to Neighbour to Neighbour for capital improvements to its Community Food Centre facility, to be located at 310 Limeridge Road West, in the amount of \$200,000 to be funded as follows:
  - (i) \$150,000 from Ward 8 Area Rating Reserve 108058,
  - (ii) \$50,000 from the Social Services Initiative Reserve Fund 112214; and,
- (b) That the Neighbour to Neighbour Community Food Centre request from City of Hamilton for an operating agreement for annual funding of \$200,000 from 2016 to 2020 be referred to the 2016 budget process, specifically as an operating budget enhancement.

WHEREAS the Medical Officer of Health, for the City of Hamilton will have the opportunity to meet with Minister of Health and Long-Term Care, and provincial staff;

- (a) That the Mayor write to the Minister of Health and Long-Term Care expressing the City of Hamilton's position and disappointment on the recent funding decision; and
- (b) That the Medical Officer of Health be directed to meet with staff from the Ministry of Health and Long-Term Care as soon as possible to discuss the following:

- (i) The new funding model, with an undertaking to evaluate and refine the model, and explore options to address the funding shortfall, and
- (ii) The provincial public health review that is underway in order to address long term programming and funding for Public Health Services, and
