2. Blanket Support Resolution for Rooftop Solar Projects for the Feed in Tariff Program (PW12069(b)) (City Wide) (Item 5.2)

That the City of Hamilton support the Independent Electricity System Operator (IESO) Feed in Tariff (FIT) Program Version 3.1 for the construction and operation of rooftop solar photovoltaic (PV) installations within the City of Hamilton by approving the Municipal Council Support Blanket Resolution, as shown in Appendix A to PW Report 15-013.

3. Transit Passenger Shelter Agreement Extension (PW15071) (City Wide) (Item 5.3)

That the General Manager of Public Works be authorized and directed to enter into negotiations with a single source, Outfront Media, for a month to month extension (to a maximum of 12 months) of the existing Hamilton Street Railway (HSR) transit passenger shelter agreement, expiring on December 31, 2015, resulting in a revised expiry date of no later than December 31, 2016 with a minimum termination notice of 60 days.

4. PRESTO Fare Card System Pilot Project and Establishment of a PRESTO Third Party Vendor Network (PW04117(h)) (City Wide) (Item 5.4)

- (a) That staff be authorized and directed to implement a PRESTO smartcard third party vendor network where PRESTO fare cards can be sold and value can be loaded on to fare cards at vendor locations in the City of Hamilton, which will include the following steps:
 - (i) entering into an agreement with Loblaws Inc. on an ongoing basis for a period of one year beginning January 1, 2016 with the option to renew for three additional one-year periods for Fortinos locations throughout the City of Hamilton:
 - (ii) adding up to 25 new vendors to the network to be selected through a request for proposals issued in accordance with the City of Hamilton Procurement Policy By-law No. 13-317, Policy #5.4;
- (b) That the General Manager of Public Works be authorized and directed to negotiate and execute all necessary documentation to implement subsection (a), all with content acceptable to the General Manager of Public Works, and in a form satisfactory to the City Solicitor.

5. Correspondence from Joseph P. Pennachetti, City Manager, City of Toronto, Respecting the Credit Valley, Toronto and Region, Central Ontario Sourcewater Protection Plan (PW15074) (City Wide) (Outstanding Business List) (Item 5.5)

That Report PW15074 respecting Correspondence from Joseph P. Pennachetti, City Manager, City of Toronto, Respecting the Credit Valley, Toronto and Region, Central Ontario Sourcewater Protection Plan, be received.

6. Building Maintenance of Retaining Walls Including 462 Wilson Street East, Ancaster (PW15068) (City Wide) (tabled at September 21, 2015 PW Meeting) (Item 8.1)

That Report PW15068 respecting the Building Maintenance of Retaining Walls Including 462 Wilson Street East, Ancaster, be received.

- 7. Transit Operating Systems Standardization (PW15072) (City Wide) (Item 8.2)
 - (a) That in accordance with City of Hamilton Procurement Policy #14 Standardization, Trapeze Software Group be approved as the standard supplier and single source provider of Transit Operating Systems;
 - (b) That the General Manager of Public Works, or designate, be authorized and directed to negotiate with Trapeze Software Group to provide and install Enterprise Asset Management (EAM) module at an upset limit of \$800,000 to be funded from Project ID 5301584501 (Trapeze EAM Fleet Management);
 - (c) That the General Manager of Public Works, or designate, be authorized and directed to negotiate with Trapeze Software Group to provide and install Automated Passenger Counters (APCs) at an upset limit of \$500,000 to be funded from Project ID 5301584505 (Transit Passenger Count System).
- 8. Extension of Red Light Camera Program (PW15073) (City Wide) (Item 8.3)
 - (a) That approval be granted to continue to operate the Red Light Camera (RLC) Program in Hamilton through to the end of 2021;

- (b) That approval be granted to extend the existing contract or enter into a new contract between the City of Hamilton and the City of Toronto, to undertake centralized municipal processing of RLC offence notices with the costs for the activity to be charged to account 55739-461010;
- (c) That approval be granted to extend the existing agreement or enter into an operational agreement with the Ministry of Transportation of Ontario, with the agreement to define the responsibilities of the City and the Province under the RLC Program and thereby authorizing and permitting the City of Toronto to obtain motor vehicle registration information necessary to lay charges under the RLC Program on behalf of the City of Hamilton, with costs for this activity to be charged to account 55738-461010;
- (d) That Traffipax LLC be awarded the contract for the provision of red light cameras, associated equipment, maintenance and data transfer services for the period 2017-2021, in accordance with the terms and conditions of the Request for Approvals executed by the City of Toronto on behalf of the City of Hamilton and other participating RLC municipalities, with the costs for the equipment rental and servicing to be charged to account 55916-461010;
- (e) That the Mayor and City Clerk be authorized to execute all agreements referred to in subsections (a) through (d), together with all other necessary documents, in a form satisfactory to the City Solicitor and with content satisfactory to the General Manager of Public Works.
