Rob Hall, Director, Public Health Services introduced Marcia Nauta, Public Health Nurse/ Bed Bug Navigator, Public Health Services, and David Brodati, Manager, Investment in Affordable Housing, Community and Emergency Services, who are both involved in the Community Bed Bug Strategy.

Marcia Nauta, Public Health Nurse addressed the Board with a fictional account of real-life experiences with bed bugs in the City of Hamilton, entitled "Arthur's Story". Her comments included, but were not limited to:

- Arthur is a retired man who has downsized from a house to a one-bedroom apartment with his wife
- Arthur's wife passed away, and Arthur suffered from a stroke, and when in hospital, he discovered that he had bed bugs bites
- The situation became much worse at home, and Arthur became isolated from his neighbours, friends and family
- At this point, Arthur came into contact with Public Health Services
- Arthur was given support and direct help

David Brodati, Manager, Investment in Affordable Housing presented the Community Bed Bug Strategy, with the aid of a PowerPoint presentation. A copy of the presentation has been added to the public record. The presentation included, but was not limited to:

- Bed bug calls, yearly totals
- The Strategy is a coordinated city-wide approach
- Mission, Goals and Priority Areas of the Strategy
- Capital Request
