PLANNING COMMITTEE REPORT 15-017

(Partridge/B. Johnson)

That Item 1 of Planning Committee Report 15-018 respecting Applications to Amend the Town of Ancaster Official Plan and Town of Ancaster Zoning By-law No. 87-57 for Lands Located at 153 Wilson Street West (Ancaster) (PED15172) be amended by adding subsection (e) which reads as follows:

(e) That the implementing by-law be revised accordingly to give effect to subsections (c) and (d).

The amended Item 1 to read as follows:

- (a) That approval be given to Ancaster Official Plan Amendment Application OPA-14-018, by Garth Trails Limited, Owner, to amend Site Specific Policy Area C, of the Ancaster Wilson Street Secondary Plan to permit a multiple dwelling with a maximum density of 161 units per hectare, where the height of the multiple dwelling shall have no more than three storeys entirely above grade at the front façade, and no more than four storeys entirely above grade at the rear, for lands located at 153 Wilson Street West (Ancaster), as shown on Appendix "A" to Report PED15172, on the following basis:
 - (i) That the draft Official Plan Amendment, attached as Appendix "B" to Report PED15172, which has been prepared in a form satisfactory to the City Solicitor, be enacted by City Council;
 - (ii) That staff be directed to settle the appeal of the Ancaster Wilson Street Secondary Plan based on the draft wording for a future Urban Hamilton Official Plan Amendment attached as Appendix "F" to Report PED15172, which is consistent with the intent of the Ancaster Wilson Street Secondary Plan Official Plan Amendment, as approved by the Director of Planning and Chief Planner, and the City Solicitor.

- (b) That approval be given to Amended Zoning By-law Amendment Application ZAC-13-014 by Garth Trails Limited, Owner, for a change in zoning from the Residential "R4-637" Zone, Modified to the Residential Multiple "RM6-665" Zone, Modified, in order to permit the development of a three-storey multiple residential building with 76 residential units and associated underground and surface parking areas, for lands located at 153 Wilson Street West (Ancaster), as shown on Appendix "A" to Report PED15172, on the following basis:
 - (i) That the draft By-law, attached as Appendix "C" to Report PED15172, which has been prepared in a form satisfactory to the City Solicitor, be enacted by City Council;
 - (ii) That the amending By-law be added to Map 1 of Schedule "B" of the Town of Ancaster Zoning By-law No. 87-57.
- (c) That the current owner, or any future owner of 153 Wilson Street West, Ancaster, and the Board of Directors of 173 Wilson Street West, Ancaster, agree to the following:
 - (i) The owner of 153 Wilson Street West, at their own expense, plant a minimum of 23 trees, 6 metres high, on the east and south perimeter property of 173 Wilson Street West to create a landscape buffer between the two adjacent properties,
 - (ii) Prior to the planting of the trees, the owners of 153 Wilson St. West and the Board of Directors of 173 Wilson St. West agree in writing to the species of trees and the location of the species to be planted in the perimeter landscape buffer,
 - (iii) That the trees have a minimum 2 year warranty,
 - (iv) That the trees be planted by June 30th, 2016.
- (d) That the external surface parking lot be constructed with impressed concrete in a flagstone pattern with a dark grey pigment or approved equal.
- (e) That the implementing by-law be revised accordingly to give effect to subsections (c) and (d).

7.1 First Nations Artefacts – Dundurn Park

(A. Johnson/Farr)

WHEREAS, Hamilton has made important efforts to cultivate a relationship of respect with the First Nations, as in the City's constructive relations with the Indigenous community in connection to the development of the Red Hill Creek Expressway;

WHEREAS, our Indigenous Justice Strategy commits the City to preserving the honour of the Crown by protecting Indigenous equality; and

WHEREAS, First Nations artefacts have been found on our municipal land (e.g. at Red Hill and Dundurn Park) and will be found again.

THEREFORE BE IT RESOLVED:

- (a) That staff be directed to review the best practices for ensuring that the honour of the Crown and Indigenous property and cultural rights are honoured in the handling of First Nations artefacts discovered on municipal land, and to consider the legal aspects of the issue as well as best practices for ensuring that First Nations artefacts are housed in rightful and appropriate locations, and report to the General Issues Committee; and,
- (b) That staff be directed to take the necessary steps, through consultation with relevant Indigenous authorities and with the archaeology program at McMaster University, to ensure appropriate handling of the artefacts discovered at Dundurn Park, including opportunities for public display of the artefacts at the Dundurn Castle site.

7.4 Conversion of Wentworth Street

(Green/Farr)

WHEREAS Council has directed staff to convert Wentworth Street to two-way traffic from Delaware Street to King Street;

WHEREAS concerns have been raised by area residents on Sanford Avenue with respect to through traffic coming from Wentworth Street as a result of the current one-way street system; and

WHEREAS in consultation with Traffic Operations and Engineering, Transportation Management staff and the Ward 2 Councillor, all parties are in agreement that Wentworth Street can be converted to two way operation for its entirety and provide a continuous northbound road network.

THEREFORE BE IT RESOLVED:

That Wentworth Street be converted to two way traffic from Delaware Street to Barton Street, such that it is a two way street for its entire length between the escarpment and Burlington St, and that this project be charged to Traffic Capital Account 4661620630 Two-way road conversions, and

That no action be taken to convert Sanford Avenue South to two-way traffic operation, from Delaware Street to King Street at this time, and that Traffic report back on this matter one year after the conversion of Wentworth St to two way traffic.

7.5 Municipal Campaign Contributions from Corporations and Trade Unions

That City Council request that the Provincial government make the required amendments to the *Municipal Elections Act, 2006* and the *Taxation Act, 2007* to:

- (a) prohibit municipal campaign contributions from corporations and trade unions; and
- (b) replace the current municipal campaign contribution rebate by extending the political contribution tax credit for individuals,

which currently applies to provincial campaign contributions, to include municipal campaign contributions.

7.6 Toll Route Program on both the Red Hill Valley Parkway and the Lincoln Alexander Parkway

WHEREAS, concerns have been raised with respect to the operations and safety of the Red Hill Valley Parkway and Lincoln Alexander Parkway; and,

WHEREAS, the initial intent of both roadways was to provide inter-city connection for both residents and the movement of goods for the City of Hamilton;

THEREFORE BE IT RESOLVED:

That Traffic Operations and Engineering staff be directed to undertake a review of the expected impacts and costs associated with implementing a Toll Route program on both the Red Hill Valley Parkway and Lincoln Alexander Parkway for the through movement of Out-of-Town Trucks and report back to Public Works Committee.

7.7 Provincial Engagement on the Cootes-to-Escarpment EcoPark System

(Partridge/VanderBeek)

WHEREAS, the collaborative nature of the Cootes-to-Escarpment EcoPark System initiative has allowed the partners to do more together than they would have been able to do alone;

WHEREAS, the long-term sustainability of the Ecopark System requires support and resources that exceed what the partners are able to contribute;

WHEREAS, supporting and investing in the Cootes-to-Escarpment EcoPark System, the government of Ontario can deliver the significant benefits of urban greenspace and biodiversity conservation at a fraction of the cost of establishing a new provincial park; and,

WHEREAS, the partners are seeking support from senior levels of government and welcome their participation in the initiative;

THEREFORE BE IT RESOLVED:

- (a) That the Mayor correspond with the Minister of Natural Resources and Forestry to request that special purpose legislation be enacted to recognize the Cootes-to-Escarpment Ecopark System as an area of Provincial significance, as a priority for funding under Provincial programs to protect and enhance natural and cultural heritage, and to grant the partner agencies powers to manage, protect and enhance this important area; and,
- (b) That the Province of Ontario be invited to join the Cootes-to-Escarpment Ecopark System partnership by becoming a party to the Memorandum of Understanding, conveying and/or enhancing ecological stewardship of Crown property and collaborating on joint initiatives.

NOTICES OF MOTION

Councillor Whitehead introduced the following Notice of Motion:

8.1 Feasibility Study to Provide a GO Bus Service on the Mountain

WHEREAS, the 403 is becoming chronically congested especially at peak hours through the Hamilton corridor, and

WHEREAS, the Lincoln Alexander Parkway has been impacted causing significant congestion at peak hours.

THEREFORE, BE IT RESOLVED:

That the City requests the Province of Ontario to embark on a feasibility study to provide a GO Bus service on the mountain; one of the considerations being a location around the airport lands.

Councillor Whitehead introduced the following Notice of Motion:

8.2 Moratorium on any New Projects, Roadway Alterations or Designs that Reduce Motor Vehicular Capacity on any Roadway within the LRT Corridor

WHEREAS the City is currently reviewing the existing road network and road use priorities via a Transportation Master Plan Update;

WHEREAS City Council has already directed staff to convert specific roadways from one-way to two-way operation which effects capacity on roadways as follows:

- (i) Bold St. from James St. S. to Queen St. S.
- (ii) Duke St. from James St. S. to Queen St. S.
- (iii) Hughson St. N. from Wilson St. to Barton St. E.
- (iv) King William St. from John St. N. to Wellington St. N.
- (v) Wentworth St. N. from Delaware Ave. to King St. E.
- (vi) Victoria Ave. N. from Barton St. E. to Burlington St. E.
- (vii) Caroline St. N. from King St. to York Blvd.
- (viii) Hess St. N. from York Blvd. to Barton St. W.

WHEREAS Traffic staff support the additional conversion of Wentworth St. N. between King St. E. and Barton St. E. such that Wentworth St be a continuous two way street between the escarpment and Burlington St.;

WHEREAS bicycle lanes have already been established or approved for implementation on Hunter St., York Blvd., Cannon St., Charlton Ave., Herkimer St., Dundurn St. and Bay St. thereby reducing motor vehicle capacity on these major roadways;

WHEREAS The Province has approved 1.2 Billion Dollars in funding for the development of Light Rail Transit (LRT) in the City of Hamilton;

WHEREAS LRT Traffic Impact studies have not yet been completed and therefore the impact of the vehicle offloading from King St. and Main St. to the adjacent surrounding road network in the lower City is unknown; and

WHEREAS the parking, delivery and loading of goods and services in the LRT corridor has not been determined;

THEREFORE BE IT BE RESOLVED:

- (a) That the City place a moratorium on any new projects, roadway alterations or designs that reduce motor vehicular capacity on any roadway within the LRT corridor, bounded by Cootes Dr., the escarpment, Hamilton Harbour and Parkdale Ave. in order to to safeguard the capacity of the existing road system within the LRT corridor such that when volumes need to be reassigned from Main and or King during the LRT Construction and subsequent operation, that there is available capacity within the remaining roadway system;
- (b) That planned or emergency roadway reconstruction, repaving of roadways and servicing of utilities in the corridor be exempt from the moratorium with the condition that they be scheduled to have minimum concurrent interference with LRT construction; and

(c)That the LRT Project Team report back to the General Issues Committee once traffic impacts studies are completed, with the expected roadway traffic volume reassignment and traffic impacts of the reassignment on roadways within the LRT corridor.

Councillor Farr introduced the following Notice of Motion:

8.3 Consulting the Affected Ward Councillor(s) when Notice of Motions Seek to Waive the Rules at Council or Standing Committee Meetings

WHEREAS, there have been Notice of Motions seeking to Waive the Rules at Council or Standing Committee meetings, which are written by staff for a Councillor outside the Wards affected by said Notice of Motion;

THEREFORE BE IT RESOLVED:

That, at the very least, those staff involved in the formulation of the Notice of Motion be directed to review the Notice of Motion with the affected Ward Councillors so that they may have a reasonable timeframe with which to engage their communities.
