Financial: The \$140,000 is totally levied by the BIA through its members. There is no

cost to the City of Hamilton for any part of the Operating Budget.

HISTORICAL BACKGROUND

After holding two members' meetings to discuss the BIA's 2016 Budget, the BIA's Board of Management approved the Budget at a meeting on November 24, 2015. The BIA forwarded correspondence to staff on November 24, 2015, asking that the revised approved Budget be forwarded to Council for its consideration.

The process followed to adopt the International Village BIA's Budget was in accordance with the *Municipal Act*, 2001, and the BIA's Procedure By-law.
