#### THE FOLLOWING ITEMS WERE REFERRED TO COUNCIL FOR CONSIDERATION:

1. Funding Source Alternatives – Hamilton Community Bed Bug Strategy (6.2)

## (Ferguson/Collins)

- (a) That the 2016 Capital Budget request for the Hamilton Community Bed Bug Strategy, in the amount of \$415,000, which includes 2 full-time equivalents (FTEs), to be funded from a Work-in-Progress transfer from the Industrial Zone Air Quality Project Account #4030707750, be approved;
- (b) That the 2017 Capital Budget request for the Hamilton Community Bed Bug Strategy, in the amount of \$380,000 to be funded from future Work-in-Progress transfers; to be identified by the Capital Projects Work-in-Progress Sub-Committee, be approved; and,
- (c) That the 2018 Capital Budget request for the Hamilton Community Bed Bug Strategy, in the amount of \$265,000 to be funded from future Work-on-Progress transfers; to be identified by the Capital Projects Work-in-Progress Sub-Committee, be approved.

## (iii) 2016 Tax Supported Capital Budget (FCS15088) (City Wide) (Item 5.3)

Mike Zegarac, General Manager of Finance & Corporate Services, addressed Committee respecting Report FCS15088. Mr. Zegarac's presentation included, but was not limited to, the following:

- Direction from the General Issues Committee on November 27, 2015:
  - Funding Options for:
    - Hamilton Community Bed Bug Strategy
    - Hamilton Plan for an Age Friendly City Initiative
    - Provincial Offences Administration (POA) Offices Building Envelope Insulation
- The Hamilton Community Bed Bug Strategy: The cost for 2016 and 2017 will be approximately \$1,060,000 and staff is recommending the following:

- That the Hamilton Community Bed Bug Strategy Capital Budget for 2016 of \$415,000 including 2 full time equivalents (FTE) be funded from a WIP transfer from the Industrial Zone Air Quality Project 4030707750; and,
- That the Hamilton Community Bed Bug Strategy Capital Budget for 2017 of \$380,000 and 2018 of \$265,000 be funded from future WIP transfers to be identified by the Capital Projects Work-in-Progress Sub-Committee.
- The Hamilton Plan for an Age Friendly City:
  - That the Hamilton Plan for an Age Friendly City 2016 Capital Budget request for \$50,000 be absorbed in the Community Services 2016 Operating Budget for Consulting Services or Tax Stabilization Reserve in the case of a 2016 corporate deficit.
- Provincial Offences Administration (POA) Building: The cost for the insulation will be approximately \$500,000 and staff is recommending the following:
  - That the insulation of the POA Building envelope for \$500,000 be funded from the Red Light Camera Reserve account #112203 and be incorporated into the 2016 Capital Budget.
- Amend Recommendation (i) in Report FCS15088 to read:
  - (i) That 2016 capital projects from the Hamilton Police Service, the Hamilton Public Library, and the Hamilton Conservation Authority (HCA), over and above projects already included in the 2016 Capital Budget, subject to approval of the respective board and Council, be funded from debt.
- Approval of the Recommendations (a) to (i) of Report FCS15088, as amended.

#### (Pearson/Conley)

That the presentation provided by Mike Zegarac, General Manager of Finance & Corporate Services, respecting Report FCS15088 – 2016 Tax Supported Capital Budget, be received.

## (e) MOTIONS (ITEM 7)

# (i) Affordable Housing Units for Seniors as Part of the Riverdale Recreation Expansion Project (Item 7.1)

#### (Collins/Merulla)

WHEREAS, there are currently over 5,000 names on the City of Hamilton's Housing Wait List;

WHEREAS, rising real estate costs in Hamilton present a significant barrier for social housing providers;

WHEREAS, the expansion of the Riverdale Recreation Centre is tentatively scheduled for 2017 and 2018 as part of the City's 10 year capital budget plan;

WHEREAS, the Riverdale Recreation Centre is operated on land owned by the Hamilton Wentworth District School Board;

WHEREAS, City Housing Hamilton may be required to replace or add new units as part of its Asset Renewal Program;

WHEREAS, seniors now represent 30% of those on Ontario's social housing wait lists (up 8% from a decade ago and rising);

WHEREAS, the construction of new affordable housing units on publicly owned land saves substantial resources for affordable housing providers;

WHEREAS, the construction of affordable housing units above a recreation facility provides tremendous health benefits to those residing in such a building; and,

WHEREAS, the construction of new affordable housing units above a City of Hamilton recreation centre is a compact form of sustainable development;

#### THEREFORE BE IT RESOLVED:

That City of Hamilton Recreation and Facilities staff be directed to convene meetings with CityHousing Hamilton staff, Hamilton District School Board staff, School Board Chair & Ward 5 Trustee, Todd White, and Housing Services staff to discuss the possibility of constructing new affordable housing units for seniors, as part of the Riverdale Recreation Expansion project, and report to the General Issues Committee with a report detailing any opportunities that might exist for a multi-stakeholder development of this kind.

WHEREAS, Oak Run Bakery has and continues to invest in their manufacturing operations and servicing; and,

WHEREAS, Oak Run Bakery has been working with the Ministry of the Environment to ensure that Oak Run Bakery has a long-term, sustainable wastewater servicing strategy, but the current soil characteristics limit the servicing options available to Oak Run Bakery;

#### THEREFORE BE IT RESOLVED:

That Oak Run Bakery be permitted to connect to the municipal wastewater system, at their cost, in a manner acceptable to the City of Hamilton.
