5. **PRESENTATIONS**

5.1 DARTS (Madelain Steller-Cain – Chair)

Carolann Fernandes provided a brief background regarding DARTS prior to the introduction of Madelain Steller-Cain. Carolann sits on the Board as a volunteer along with other citizens who provide over-site and accountability. Madelain gave a PowerPoint presentation. Tammy Morasse provided a presentation regarding Ontario's Long-Term Affordable Housing Strategy. Tammy was seeking input from the Committee members for a report being sent to Emergency & Community Services Committee in June and feedback to the Ministry of Municipal Affairs and Housing by July 3, 2015. The Committee members then participated in a consultation exercise providing Tammy with information on four key themes.

6.2 Committee/Sub-committee Updates

a) Housing Sub-committee (C. Fernandes)

Carolann Fernandes noted that the Sub-committee has been meeting diligently towards finalizing the Housing booklet. The final draft has been given to Mark Weingartner and he will have his communications staff look at the document. A mock-up will be provided for final proofreading and then to printing. The expectation is to have the booklet ready for distribution during seniors' Month. Carolann thanked the Sub-committee members for all their hard work.

b) Transportation Sub-committee (J. Mayo)

Jeanne Mayo provided the Committee with a report on sidewalks. The following recommendations were brought forward:

Urge Hamilton City Council:

- To ensure the implementation of the guidelines with regard to width of sidewalks in all contracts that involve sidewalks, either repair or new installation
- To ensure that all sidewalks are kept in good repair to minimize accidents and bumps for wheelchairs and walkers
- To continue to install Urban Braille
- To create and disseminate a publicity program to encourage safe walking habits and sharing of sidewalk space amongst pedestrians and mobility device users

e) Older Adult Network (D. Chartrand)

Deirdre Chartrand passed out a flyer for the Seniors Kickoff – June 1 – and reminded everyone that there will be no food vendors. Marjorie Wahlman noted that the event will be bigger and better this year. She also advised that regular clients of DARTS, if they book 7 days in advance of the event, can go free of charge to and from the event.

f) Seniors Award Event (L. Maychak)

The event is being held at Michelangelo's and ticket price is \$25. Tickets are being sold at various locations. Everyone is welcome to attend. Lisa will bring some tickets to the next meeting. Again this year, the tickets for Committee members will be subsidized by \$10 thereby making the cost for members to be \$15. Tom Jackson thanked Lisa for her current and past work on this event. It was also noted that Lisa was originally seconded to this position and has recently been made permanent.

g) Age Friendly (M. Weingartner)

In Mark's absence, Jeanne Mayo spoke to this matter. A significant number of people attended a function in Toronto representing the Age-Friendly Plan. The final stages of the implementation plan are being worked on during the summer and the expectation is that the governance plan will be wrapped up in June.

7.4 Update from Councillor Jackson

- a) Happy news from Council 86% approval for HSR employees, so no strike or lockout.
- b) If anyone had a frozen water line on the City side, forward your claim to Councillor Jackson's office and it will be reviewed for reimbursement.
- c) Canada Post this matter will be dealt with at the John Sopinka Court House on May 28 when evidence is given by both sides. We are becoming the test area for this issue. Hopefully, the by-law will be upheld. The City wanted to request an injunction but Canada Post went to Court first to stop the injunction. Council is aware of the mailboxes being installed. If it is without a permit, report the address to Councillor Jackson.

Carolann Fernandes advised that where she lives is a proposed location. Councillor Jackson noted that the contractor is caught in the middle. Penelope Petrie noted that the mailboxes located on corner lots encourage people to stop on the street and create traffic congestion.
