## THE FOLLOWING ITEMS WERE REPORTED FOR THE CONSIDERATION OF COUNCIL:

1. Endorsement of Report "The Right to an Adequate Standard of Living: An Update to the 2006 Report" to the United Nations Committee on Economic, Social and Cultural Rights in Geneva (City Wide) (Added Item 6.1)

#### (Merulla/A. Johnson)

- (a) That Hamilton City Council endorse the report "The Right to an Adequate Standard of Living: An Update to the 2006 Report", and write to the United Nations Committee on Economic, Social, and Cultural Rights to confirm that endorsement to the United Nations Committee;
- (b) That the General Manager of Community & Emergency Services be directed to research the possibility of the City of Hamilton becoming a Human Rights City (i.e. a discussion that is currently underway in our sister cities of Edmonton, AB, and Winnipeg, MB); and
- (c) That the General Managers of Community & Emergency Services and Finance & Corporate Services be directed to work in conjunction with the Hamilton Community Legal Clinic (HCLC), to incorporate the issue of the cost of federal-provincial downloading to municipalities in the report as this further impoverishes the citizens of Hamilton; and

(d) Request language in the submission that is both gender and orientation neutral.

## 3. McQuesten Urban Agricultural Social Enterprise and Community Gardens (CES14037(a)) (City Wide) (Item 8.1)

- b) Additional funding for costs incurred as a result of SAMS implementation once the system has stabilized and the amount of deferred work and associated lost revenues has been determined: and
- c) A copy of this report be circulated to the Association of Municipalities of Ontario (AMO), all Members of Provincial Parliament, and the Ontario Municipal Social Services Association.

Denise Christopherson and Medora Uppal, appeared and spoke on before the Committee regarding the YWCA Hamilton's Transitional Living Program for Women. Ms. Christopherson and Ms. Uppal noted that the Program is in high demand and despite advocacy work being done, lack of funding has created a significant challenge for the YWCA. In providing an overview of investments and the work that is being done to date, the YWCA Hamilton's Transitional Living Program for Women is experiencing a shortfall of \$125,000. Ms. Christopherson and Ms. Uppal requested funding from the city and encouraged Committee to consider these challenges during the 2016 budget process.
