RECOMMENDATION

- (a) That a Hamilton Tax Increment Grant Program (HTIGP) Application submitted by 2452849 Ontario Inc. (Darko Vranich), for the property at 220 Cannon Street East, Hamilton, for a Hamilton Tax Increment Grant Program (HTIGP) Grant estimated at \$552,695.56 over a maximum of a five-year period, and based upon the incremental tax increase attributable to the redevelopment of 220 Cannon Street East, Hamilton, be authorized and approved in accordance with the terms and conditions of the HTIGP:
- (b) That the Mayor and City Clerk be authorized and directed to execute the Grant Agreement, attached as Appendix "A" to Report PED16069, in a form satisfactory to the City Solicitor.

EXECUTIVE SUMMARY

The Hamilton Tax Increment Grant Program (HTIGP) Application for the redevelopment of 220 Cannon Street East, Hamilton, was submitted by 2452849 Ontario Inc. (Darko Vranich). The applicant proposes to develop a 12-storey, 100-unit apartment building with underground parking on the existing commercial vacant land.

Development costs are estimated at \$24,380,631 and it is projected that the proposed redevelopment will increase the assessed value of the property from its current estimate of \$251 K to approximately \$16 M. This will increase total annual property taxes generated by the property. The municipal share of this property tax increase (municipal

tax increment) will be approximately \$184,231.86, of which 100% would be granted to the owner during year one, 80% or approximately \$147,385.48 in year two, 60% or approximately \$110,539.11 in year three, 40% or approximately \$73,692.74 in year four and 20% or approximately \$36,846.37 in year five. The estimated total value of the grants is approximately \$552,695.56.

Upon completion of the redevelopment and reassessment of the property by the Municipal Property Assessment Corporation (MPAC), staff will report back in an Information Update to Council on the actual redevelopment costs, the reassessment amount determined by MPAC and the actual grant amount.

FINANCIAL - STAFFING - LEGAL IMPLICATIONS

Financial: The City will collect full property taxes on the property and, in turn, provide a grant for five years, declining each year after the first year by 20%, based on the increase in the municipal portion of the taxes, post-development completion of 220 Cannon Street East, Hamilton. Following year one of the grant payment, the City will start to realize the positive results of the Program from a financial perspective. Based on the projected figures, the estimated tax increment over five years totals \$921,159.30, of which the applicant would receive a grant totalling \$552,695.56 and the City retaining taxes totalling \$368,463.74.

Staffing:

Applicants and subsequent grant payments under the HTIGP are processed by the Urban Renewal Section and Taxation Division. There are no additional staffing requirements.

Legal:

Section 28 of the *Planning Act* permits a municipality, in accordance with a Community Improvement Plan, to make loans and grants which would otherwise be prohibited under Section 106(2) of the Municipal Act, to registered / assessed owners and tenants of lands and buildings. Community Improvement Plan can only be adopted and come into effect within a designated Community Improvement Project Area. Changes to a Community Improvement Plan or Community Improvement Project Area require formal amendments as dictated by the *Planning Act*.

The grant will be supported by a Grant Agreement, attached as Appendix "A" to Report PED16069, which has been developed in consultation with the Legal Services Division and will be executed by the Applicant prior to commencing grant payments.

HISTORICAL BACKGROUND

City Council, at its meeting held August 22, 2001, approved an amendment to the Downtown and Community Renewal Community Improvement Plan which introduced the HTIGP. Since that time, a number of Program refinements have been approved by City Council, the most recent amendment being the expansion of the Program to Community Downtowns, Business Improvement Areas, the Mount Hope / Airport Gateway and the corridors of Barton Street and Kenilworth Avenue, as identified in the Downtown and Community Renewal Community Improvement Project Area. The terms of the Program offer a five-year grant not to exceed the increase in municipal realty taxes as a result of the development. The grant is to be in an amount which does not exceed 100% of the municipal realty tax increase during the first year, 80% in year two, 60% in year three, 40% in year four, and 20% in year five.

The proposed project at 220 Cannon Street East, Hamilton, is an eligible project under the terms of the HTIGP. The applicant will qualify for the HTIGP grant upon completion of the redevelopment project which will result in the development of a 12-storey, 100 unit apartment building with underground parking on existing commercial vacant land. Development costs are estimated at \$24,380,631. The total estimated grant over the five-year period is \$552,695.56.

POLICY IMPLICATIONS AND LEGISLATED REQUIREMENTS

On November 11, 2015, Council approved Amendment No. 41 (By-law No. 15-256) to the Urban Hamilton Official Plan which re-designated the lands at 220 Cannon Street East, from "Low Density Residential" to "Mixed Used" and established a Site Specific Policy Area in order to permit the development of the lands for a 100 unit mixed use commercial / residential building, with a maximum height of 12-storeys and maximum residential density of 705 units per hectare. The "Mixed Use" designation permits the residential use as proposed.

On November 11, 2015, Council also approved a Zoning By-law 05-200 amendment (By-law No. 15-257) for the lands located at 220 Cannon Street East. The rezoning modifications involved a change in zoning from the Downtown Residential (D5) Zone to the site-specific Downtown Mixed Use (D3, 470) Zone to allow the mixed used development proposal and to also address other matters relating to parking, visual barrier and height.

RELEVANT CONSULTATION

Staff from the Taxation Division, Corporate Services Department, and the Legal Services Division, City Manager's Office, was consulted and the advice received is incorporated into Report PED16069.

ANALYSIS AND RATIONALE FOR RECOMMENDATIONS

Urban Renewal staff, in co-operation with staff from the Taxation and Legal Services Divisions, developed an estimated schedule of grant payments under the terms of the Program. The final schedule of grant payments will be contingent upon a new assessment by MPAC following completion of the project. The Applicant will be required to sign the Grant Agreement, attached as Appendix "A" to Report PED16069. The Grant Agreement contains provisions for varying the grant payment in each and every year based on MPAC's assessed value. By signing, the Applicant will accept the terms and conditions outlined therein prior to any grant payments being made. The following provides an overview of the estimated grant calculation for 220 Cannon Street East, Hamilton, as presented in Appendix "A" to Report PED16069.

The Agreement also outlines the terms and conditions of the grant payments over the five-year period. Key terms and conditions include the following:

The Agreement also outlines the terms and conditions of the grant payments over the five-year period. Key terms and conditions include the following:

- Property owner must maintain property taxes in good standing. Properties must have no outstanding work orders and / or orders or requests to comply from any City department or other regulatory authority;
- The grant payment is recalculated annually;
- Annual grant payments after the first grant payment are adjusted downward in the event the municipal tax increment in any subsequent year has been reduced;
- The property must be maintained in its rehabilitated state;
- If property taxes are owing for more than one full year, the City will have the option, without notice and at its own discretion, to terminate all future grant payments;
- In the event of the sale, conveyance, transfer or entering into of any agreement of sale or transfer of the title of the property, the City shall have absolute discretion in ceasing any further grant payments; and,
- Where, in the opinion of Council, the commercial relationship between the City and the Applicant has been impaired by, but not limited to, the Applicant being involved in litigation with the City, the City may, at its discretion and without notice, terminate all future grant payments. Applicants are individuals, corporate entities and individuals behind the corporation (Officers / Directors / Shareholders).

ALTERNATIVES FOR CONSIDERATION

Decline the Grant and Approve a Reduced Amount

Declining a grant and / or approving a reduced amount would undermine the principles of the HTIGP and regeneration efforts, in general, and could potentially terminate or delay the project. This alternative is not recommended.

not be issued.
