## **CITY OF HAMILTON**

### **BY-LAW NO. 16-**

#### **To Authorize the Execution of a Contribution Agreement between the City of Hamilton and Her Majesty the Queen in right of Canada as represented by the Minister responsible for the Federal Economic Development Agency for Southern Ontario to Receive Funding Under the Canada 150 Community Infrastructure Program**

**WHEREAS** in accordance with a motion approved by the Council of the City of Hamilton on June 3, 2015, the City of Hamilton applied to receive funding for projects under the Canada 150 Community Infrastructure Program;

**AND WHEREAS** the Federal Economic Development Agency for Southern Ontario has approved funding for eight City of Hamilton projects under the Canada 150 Community Infrastructure Program listed in Schedule 1 to this By-law;

**AND WHEREAS** the Council of the City of Hamilton has authorized the signing of a contribution agreement with Her Majesty the Queen in right of Canada as represented by the Minister responsible for the Federal Economic Development Agency for Southern Ontario to receive funding for the approved projects under the Canada 150 Community Infrastructure Program;

**NOW THEREFORE** the Council of the City of Hamilton enacts as follows:
