**BECAUSE BEER CRAFT BEER FESTIVAL – SPECIAL OCCASION PERMIT
LIQUOR LICENCE**

WHEREAS, Hamilton City Council has received Notice (attached hereto as Appendix “A”) from Mr. Tim Potocic on behalf of the Sonic Unyon, that they wish to obtain approval for a Special Occasion Permit Liquor Licence to sell alcohol on July 8, 2016 between the hours of 3:00 p.m. and 11:00 p.m. and July 9, 2016 between the hours of 2:00 p.m. and 11:00 p.m. at Pier 4 Park located at 64 Leander Dr., Hamilton, Ontario, during the Because Beer Craft Beer Festival taking place in Hamilton, Ontario;
