1. **Affordable Access Strategy 5-Year Update (CS10047(b)) (Item 5.1)**

5. Support of Improving Provincial Social Assistance Programs (City Wide) (Item 6.1)

(Merulla/Farr)

(a) That the Mayor correspond with the Premier of Ontario and the Minister of Community and Social Services, requesting that the Government of Ontario immediately address the inadequacy of provincial social assistance benefits through a substantial increase to benefits, coupled with an arms-length mechanism to annually set future evidence based rates that will allow individuals and families to meet at least their basic needs; and

(b) That the Mayor correspond with the Premier of Ontario and the Minister of Community and Social Services, requesting that the Government of Ontario proceed with social assistance reform to alter the structure of the Ontario Works program benefits to acknowledge that many individuals and families in receipt of Ontario Works benefits face long-term barriers to employability, and thus require additional financial assistance (for example, to replace items such as furniture).

7. Update to the Ontario Long Term Affordable Housing Strategy and the 2016 Federal Budget Housing Investments (CES15032(a)) (City Wide) (Item 7.2)

That Report CES15032(a), respecting Update to the Ontario Long Term Affordable Housing Strategy and the 2016 Federal Budget Housing Investments, be received.

8. Supporting the Implementation of the Provincial Long Term Affordable Housing Strategy (CES15032(a)) (City Wide) (Item 7.2)

(Farr/Skelly)

WHEREAS, the Honourable Ted McMeekin, Minister of Municipal Affairs and Housing has announced the Provincial Long-Term Affordable Housing Strategy Update;

WHEREAS, as part of the Long Term Affordable Housing Strategy Update, the Province has committed to conducting extensive consultations on various initiatives to increase the supply of affordable housing, including inclusionary zoning; modernizing social housing programs, including developing more co-ordinated and effective access to the housing system, developing a portable system of housing subsidy, and simplifying rent-gear-to-income calculations; transforming the supportive housing system; developing an Indigenous specific housing strategy; and undertaking key steps to ending homelessness;

WHEREAS, as part of the Long Term Affordable Housing Strategy Update, and the 2016 Ontario Budget, the Province has committed \$178 million to implement the Strategy and transform the housing system;

WHEREAS, the City of Hamilton has demonstrated the capacity for Provincial leadership by sitting on the Expert Advisory Panel on Homelessness convened by the Honourable Ted McMeekin;

WHEREAS, the outcomes of the Province's consultations will impact the ability of the City of Hamilton to address Hamilton's housing issues and implement the City of Hamilton's Housing and Homelessness Action Plan; and

WHEREAS, the City of Hamilton has invested \$1.1 million annually in the operating budget for housing allowances.

THEREFORE BE IT RESOLVED:

- a) That staff be directed to play a leadership role with the Province on implementation of the Long Term Affordable Housing Strategy, by seeking

a position on any committees related to implementation of the Strategy, and participating in implementation consultations;

- b) That the Mayor send a letter to the Honourable Ted McMeekin, Minister of Municipal Affairs and Housing asking that the City of Hamilton be provided the opportunity to participate on any steering committees that may be formed to implement the Long Term Affordable Housing Strategy; and
- c) That the General Manager of Emergency and Community Services be directed to submit a proposal for the City of Hamilton to be included as one of approximately three municipalities to pilot an affordable housing benefit program for survivors of domestic violence.

**9. ArcelorMittal Dofasco Grassroots Soccer Program (CES16022) (City Wide)
(Item 8.1)**

(Green/Jackson)

- (a) That the City of Hamilton enter into a ten (10) year agreement with ArcelorMittal Dofasco G.P. and the Hamilton and District Soccer Association that will allow the City of Hamilton to administer funding of \$250,000 contributed by ArcelorMittal Dofasco to support the ArcelorMittal Dofasco Grassroots Soccer program over the next 10 years;
- (b) That the Mayor and City Clerk be authorized and directed to execute an agreement on behalf of the City of Hamilton in a form that is satisfactory to the City Solicitor;
- (c) That the General Manager of Community and Emergency Services or designate be granted the delegated authority to approve any subsequent changes to the agreement and execute any related or ancillary documentation as may be required to give effect thereto, in a form satisfactory to the City Solicitor; and,
- (d) That the General Manager of Community and Emergency Services or designate, be nominated as the representative of the City of Hamilton for the purpose of administering the agreement.

11. Single-Source Paramedic Service Linen Supply, Cleaning and Replacement (CES16001(a)) (Item 8.3)

(Farr/Skelly)

- (a) That Council approve the single source procurement, pursuant to Procurement Policy #11 – Non-competitive Procurements, for the supply, cleaning and replacement of health care linen for the Hamilton Paramedic Service for a five year period ending December 31, 2020; and,
- (b) That the General Manager, Community and Emergency Services Department be authorized to negotiate, enter into and execute a Contract and any ancillary documents required to give effect thereto with Mohawk Shared Services Inc. (MSSI), in a form satisfactory to the City Solicitor.

- (a) That Housing Services Division staff be directed and authorized to continue to provide support and assistance as required by the new Urban Native Homes' Board of Directors to ensure its immediate stability as a housing provider that provides housing and supports addressing the needs of the local Aboriginal community;
- (b) That Housing Services' Division staff be directed and authorized to request a proposal for services and/or a portfolio transfer plan from Ontario Aboriginal Housing Services for the consideration of the Service Manager;
- (c) That the General Manager of Community & Emergency Services be authorized and directed to approve and execute any agreements or other documents as may be required to give effect to Recommendations (a) and (b) of Report CES16024, in forms satisfactory to the City Solicitor; and,
- (d) That the General Manager of Community & Emergency Services be authorized and directed to reduce the subsidy payment to Urban Native Homes Inc. to offset any costs associated with Recommendations (a) and (b) of Report CES16024.

(i) Delegation Request by Craig Foye, Hamilton Community Legal Clinic, respecting Support of Improving Provincial Social Assistance Programs (Added as Item 6.1)

Mr. Tom Cooper, on behalf of Craig Foye, addressed the Committee respecting Support of Improving Provincial Social Assistance Programs.

The presentation included, but was not limited to, the following:

- Issue of the former "Permanently Unemployable" category from the former *Family Benefits Act*.
- Concerns regarding the Provincial social assistance programs in the Hamilton community respecting ineligibility.
- Community members who are disabled and financially eligible for ODSP yet not receiving these benefits due to systematic issues or other.
- Move towards an evidence-based approach, as demonstrated by MPP Miller's passing of Bill 185 by 80-0 (all parties in support) in the Ontario Legislature to create a Social Assistance Research Commission.
- The Commission would include people with lived experience on social assistance who will base social assistance rates on regional, specific cost-of-living evidence.

That the delegation presented by Tom Cooper, on behalf of Craig Foye, respecting Support of Improving Provincial Social Assistance Programs, be received.

- Immediate reforms and new funding which includes the Province's commitment to \$178-million over three years and the Federal Government's \$2.3 billion dollar investment over two years.
