**CITY OF HAMILTON**

**BY-LAW NO. 16-**

**To Amend By-law No. 01-215  
Being a By-law To Regulate Traffic**

**WHEREAS** sections 8, 9 and 10 of the Municipal Act, 2001, S.O. 2001, c. 25, authorize the City of Hamilton to pass by-laws as necessary or desirable for the public and municipal purposes, and in particular paragraphs 4 through 8 of subsection 10(2) authorize by-laws respecting: assets of the municipality, the economic, social and environmental well-being of the municipality; health, safety and well-being of persons; the provision of any service or thing that it considers necessary or desirable for the public; and the protection of persons and property;

**AND WHEREAS** on the 18th day of September, 2001, the Council of the City of Hamilton enacted By-law No. 01-215 to regulate traffic;

**AND WHEREAS** it is necessary to amend By-law No. 01-215.

**NOW THEREFORE** the Council of the City of Hamilton enacts as follows:

1. Schedule 2 (Speed Limits) of By-law No. 01-215, as amended, is hereby further amended by removing from Section "E" (Hamilton) thereof the following items, namely:

"Appleblossom Dr.	Moonbeam Dr.	50 metres south of Chester Ave.	40
Winchester Boulevard	Tenth Avenue	Ninth Avenue	40
Bond Street North	King Street West	100m north of Glen Road	40"

And by removing from Section "F" (Stoney Creek) thereof the following item, namely:

"Candlewood Drive	Whitedeer Road	Foxmeadow Drive	40"

Lawrence	King to 60 m southerly	3 <sup>rd</sup> lane from east curb	Anytime	Northerly to Westerly"

And by adding to Section "E" (Hamilton) thereof the following items, namely;

"King Street	Lawrence Road to 75m westerly	South curb lane	Anytime	Easterly to Southerly
King Street	Lawrence Road to 200m easterly	North curb lane	Anytime	Westerly to Northerly
King Street	Red Hill Valley Parkway Northbound On-Ramp to Lawrence Road	South curb lane	Anytime	Easterly to Southerly
Lawrence Road	King Street to 115m southerly	East curb lane	Anytime	Northerly to Easterly"

3. Subject to the amendments made in this By-law, in all other respects, By-law No. 01-215, including all Schedules thereto, as amended, is hereby confirmed unchanged.
