- Meeting with the Design Review Panel prior to public participation regarding a submission is a dangerous situation
- We cannot describe a project fully at this point in the process
- Public consultation after the application is deemed complete would make sense
- Reports and studies cost a great deal of money
- Let's reduce the 1000 days, let's move on to good urban design and let's participate with neighbourhoods as best we can
