Film Office – Permit Process LEAN Six Sigma Review

The Problem Statement

From August 2015 – August 2016 the Film Office issued 547 film permits to Film Production Companies and received **complaints from 41 residents.**

The good news: only 8% of film permits received in complaints.

However, complaints mean residents are experiencing frustrations around filming and likely reached a "boiling point" (small but mighty) before contacting the city (Film Office and/or their Councillor).


Goal:

To reduce the number of annual complainants for Film Permits by 25%

Baseline


"Forensics analysis"

547 film permits → 41 people who complained → 51 complaints across 8 categories:

Solutions: Focused on Parking Complaints

Development of new guideline

- Step one: Parking now provides the Film Office with parking details for the proposed permit area (# of residential parking permits + what/if parking restrictions exist that limit parking to 1-3 hours)
- Step two: Film Office determines if we have issued two (2)+ permits in that calendar year for the proposed permit area
- Step three: In areas where parking identifies permit holders and/or parking restrictions we respond to the Production Companies and let them know:
 - The # of permit holders they need to coordinate alternate parking
 - We can only approve two (2) blocks for on-street parking within the filming area

Benefits

Reality vs perception \rightarrow only 8% of permits receive complaints Categorization of types of complaints and use of data to identify the biggest issue

Consistent, standardized solution \rightarrow early success \rightarrow zero parking complaints in September (the busiest month; 7 last Sept)

Longer term: solutions will help demonstrate we are listening to resident complaints and Councillor concerns; stabilize the process and build trust and confidence in government along with an understanding of the benefits of filming in Hamilton

Learning/Issues/Next Steps/Other Information

Finding an optimal solution may take time \rightarrow balancing act to ensure all parties are satisfied (City, Film Industry and Residents); ongoing plan-do-check-act (PDCA) + follow up in 3 months
