WHEREAS the current name of the property, City of Hamilton Community Centre is confusing to residents because of the similarity to the Stoney Creek Recreation Centre in Ward 9; and

WHEREAS the current location of the property is in Saltfleet;

THEREFORE BE IT RESOLVED THAT:

That city staff be directed to report back to the Facility Naming Sub-Committee on the feasibility of the Hamilton Community Centre, located at 605 Highway No.8, Stoney Creek, being renamed the Saltfleet Community Centre.

Councillor Farr introduced the following Motion:

WHEREAS there are currently two Beasley Community Centres on the same grounds in the Beasley Neighbourhood; and

WHEREAS the Beasley Neighbourhood is arguably one of the most engaged in the City of Hamilton and the Beasley Neighbourhood Association (BNA) has recently shared an interest in a renaming of the Old Beasley Community Centre;

THEREFORE BE IT RESOLVED:

That the staff be directed to investigate the feasibility of renaming the Old Beasley Community Centre and that the Beasley Neighbourhood Association be included in the feasibility discussion.
