CITY OF HAMILTON

BY-LAW NO. 16-

**To Amend By-law No. 01-218, as amended,
Being a By-law To Regulate On-Street Parking**

WHEREAS *Section 11(1)1 of the Municipal Act, S.O. 2001, Chapter 25*, as amended, confers upon the councils of all municipalities the power to enact by-laws for regulating parking and traffic on highways subject to the *Highway Traffic Act*,

AND WHEREAS on the 18th day of September, 2001, the Council of the City of Hamilton enacted By-law No. 01-218 to regulate on-street parking;

AND WHEREAS it is necessary to amend By-law No. 01-218, as amended.

NOW THEREFORE the Council of the City of Hamilton enacts as follows:

1. Schedule 8 (No Parking Zones) of By-law No. 01-218, as amended, is hereby further amended by adding to Section "D" thereof the following items, namely:

"Cleghorn	West	Whitwell to Windwood	December 1 st to March 31 st
Donald Bell	North	Great Oak Trail to 69 Donald Bell	December 1 st to March 31 st
Gowland	South	Bradley to westerly end	December 1 st to March 31 st
Lynch	East, South & West	West intersection of Gowland to east intersection of Gowland (inside of crescent)	December 1 st to March 31 st
Powell	West	Whitwell to Windwood	December 1 st to March 31 st
Whitwell	North	Fowler to westerly end	December 1 st to March 31 st
