BY-LAW NO. 16-

Respecting Removal of Part Lot Control for the Creation of Maintenance Easements Regarding Lots 6, 16-23 (inclusive), 26-29 (inclusive), 31, 36-38 (inclusive), 43, 44, 62, 67-69 (inclusive), 71, 72, 85-88 (inclusive), 93-96 (inclusive), 106-109 (inclusive), 113-115 (inclusive), and 117 on Registered Plan 62M-1218 known as "Waterdown Meadows – Phase 3" (Flamborough)

WHEREAS the sub-section 50(5) of the *Planning Act*, R.S.O. 1990, Chapter P.13, as amended, establishes part-lot control on land within registered plans of subdivision;

AND WHEREAS sub-section 50(7) of the *Planning Act*, provides as follows:

"(7) **Designation of lands not subject to part lot control.** -- Despite subsection (5), the council of a local municipality may by by-law provide that subsection (5) does not apply to land that is within such registered plan or plans of subdivision or parts of them as are designated in the by-law."

AND WHEREAS the Council of the City of Hamilton is desirous of enacting such a by-law with respect to the lands hereinafter described;

NOW THEREFORE the Council of the City of Hamilton enacts as follows:

1. Sub-section 5 of Section 50 of the *Planning Act*, for the purpose of creating maintenance easements, as shown as Parts 1-21 (inclusive) on Plan 62R-20409, Parts 1-24 (inclusive) on Plan 62R-20410, and Parts 1-2 (inclusive) on Plan 62R-20420 shall not apply to the portion of the Registered Plan of Subdivision that is designated as follows, namely:

Lots 6, 16-23 (inclusive), 26-29 (inclusive), 31, 36-38 (inclusive), 43, 44, 62, 67-69 (inclusive), 71, 72, 85-88 (inclusive), 93-96 (inclusive), 106-109 (inclusive), 113-115 (inclusive), and 117, on Registered Plan 62M-1218, in the City of Hamilton.

2. This By-law shall be registered on title to the said designated land and shall come into force and effect on the date of such registration.
