## CITY OF HAMILTON

## **BY-LAW NO. 16-**

Respecting Removal of Part Lot Control from Lots 1, 4, 5, 8-10, 13, 14, 33-35, 46, 47, 49-61, 74-84, 98, 99, 101-105, 120, 121, 123 and 124 and Blocks 125 and 126 on Registered Plan 62M-1218, "Waterdown Meadows – Phase 3" and from Lot 80 on Registered Plan 62M-1131, "MC2 Homes – Phase 1", Flamborough

**WHEREAS** the sub-section 50(5) of the *Planning Act*, R.S.O. 1990, Chapter P.13, as amended, establishes part-lot control on land within registered plans of subdivision;

**AND WHEREAS** sub-section 50(7) of the *Planning Act*, provides as follows:

"(7) **Designation of lands not subject to part lot control.** -- Despite subsection (5), the council of a local municipality may by by-law provide that subsection (5) does not apply to land that is within such registered plan or plans of subdivision or parts of them as are designated in the by-law."

**AND WHEREAS** the Council of the City of Hamilton is desirous of enacting such a by-law with respect to the lands hereinafter described:

**NOW THEREFORE** the Council of the City of Hamilton enacts as follows:

1. Sub-section 5 of Section 50 of the *Planning Act*, for the purpose of creating maintenance easements, as shown as Parts 1-12 (inclusive) on Plan 62R-20359, Parts 1-20 (inclusive) on Plan 62R-20360, and Parts 1-26 (inclusive) on Plan 62R-20361 and for the purpose of creating 12 lots for street townhouses, inclusive of additional maintenance easements, as shown as Parts 21-33 (inclusive) on Plan 62R-20360 and Parts 27-39 on Plan 62R-20361 shall not apply to the portion of the Registered Plan of Subdivision that is designated as follows, namely:

Lots 1, 4, 5, 8-10, 13, 14, 33-35, 46, 47, 49-61, 74-84, 98, 99, 101-105, 120, 121, 123 and 124 and Blocks 125 and 126 on Registered Plan 62M-1218, and Lot 80 on Registered Plan 62M-1131.

2. This By-law shall be registered on title to the said designated land and shall come into force and effect on the date of such registration.
