2. Everyone Rides Initiative Pilot Project (PW16086) (City Wide) (Item 5.2)

- (a) That the General Manager, Public Works, be authorized to:
 - (i) Implement the City of Hamilton's Everyone Rides Initiative Pilot Project as outlined in Information Report No. PW13015c, dated December 7, 2015 and execute on behalf of the City any related agreements (in a form satisfactory to the City Solicitor) at an estimated cost of \$525,000;

- (ii) Execute, on behalf of the City, any agreements (in a form satisfactory to the City Solicitor) with the Federation of Canadian Municipalities (FCM) related to the City's acceptance the Green Municipal Fund Grant;
- (iii) Execute, on behalf of the City, any agreements (in a form satisfactory to the City Solicitor) with the Hamilton Community Foundation (HCF) related to the City's acceptance of the 2016 HCF Grant;
- (iv) Allocate \$201,255 from the Transportation Demand Management and Smart Commute account (4031655820) to the Everyone Rides Initiative Pilot Project account, which includes \$126,255 from Sustainable Mobility and \$75,000 from Barton-Kenilworth Urban Renewal:
- (v) Negotiate a non-competitive single source purchase arrangement with Social Bicycles Inc. for the purchase of bikes, hubs and related infrastructure, to an upset limit of \$225,000, and execute on behalf of the City any related agreements (in a form satisfactory to the City Solicitor);
- (vi) Negotiate a non-competitive single source purchase arrangement with Hamilton Bike Share Inc. (SoBi Hamilton) to implement the Everyone Rides Initiative Pilot Project to an upset limit of \$300,000 and execute on behalf of the City any related agreements (in a form satisfactory to the City Solicitor);
- (vii) Implement, and sign any required documentation related to, the capital budget appropriations outlined in this report; and,
- (b) That the General Manager, Public Works report back to Council subsequent to the conclusion of the Everyone Rides Initiative Pilot Project;

(i) Ancaster Tennis Club – Request for Installation of Winter Tennis Air-Supported Dome Structure (Bubble) (Added Item 10.4)

Councillor Ferguson introduced the following Notice of Motion:

WHEREAS, the Ancaster Tennis Club has five new reconfigured courts, along with a new clubhouse located in Village Green Park in the core of Ancaster Village;

WHEREAS, since the time of these improvements, membership has increased substantially from 350 members in 2011, to 711 in 2016 (with 235 of the current members being junior members;

WHEREAS, our junior members need access, on a local basis, to continue their development over a 12 month time frame, to reach their potential;

WHEREAS, the recent change in ownership, and fire, at the Jewish Community Center in Ancaster means Rosedale Tennis Club is the sole winter tennis facility available within the City of Hamilton; and,

WHEREAS, the Ancaster Tennis Club has approached the City of Hamilton with a request to investigate the feasibility of renting and installing a winter tennis air-supported dome structure (bubble) over the new courts in Village Green Park for the winter months beginning in November of 2017- March 2018 with no cost to taxpayers;

THEREFORE BE IT RESOLVED:

That Public Works staff, in conjunction with Recreation staff, be directed to explore the possibility of this request by the Ancaster Tennis Club, to install a tennis air-supported dome structure (bubble) at Village Green Park for the winter months, and report back to the Public Works Committee by February 2017.

WHEREAS the Ward 8 office, through discussion with residents has received many concerns and complaints regarding the speeding along Scenic Drive; and

WHEREAS this location is on a sharp curve and has an increase in foot traffic without sidewalks or safe passage due to its close proximity to the Bruce trail along the Escarpment and Community Mailboxes.

THEREFORE BE IT RESOLVED:

- (a) That staff be directed to install 3-Way Stop Signs at the intersection of Scenic Drive and Chateau Court; and
- (b) That staff be directed to prepare the appropriate by-law to permit 3-Way Stop Signs to be installed at the intersection of Scenic Drive and Chateau Court.

(ii) 3-Way Stop Signs at Scenic Drive and West 34th Street (Ward 8) (Added Item 10.2)

Councillor Whitehead introduced the following Notice of Motion:

WHEREAS the Ward 8 office, through discussion with residents has received many concerns and complaints regarding the speeding along Scenic Drive;

THEREFORE BE IT RESOLVED:

- (a) That staff be directed to install an All-way Stop at the intersection of Scenic Drive and West 34th Street; and
- (b) That staff be directed to prepare the appropriate by-law to permit All-Way Stop to be installed at the intersection of Scenic Drive and West 34th Street.

(iii) Retaining Walls on Guildwood Drive (Ward 8) (Added Item 10.3)

Councillor Whitehead introduced the following Notice of Motion:

WHEREAS, the City of Hamilton approved the materials and design work for the retaining walls along Guildwood Drive, Hamilton;

WHEREAS, the retaining wall along Guildwood Drive is crumbling; preventing residents from safely spending time in their backyards; and,

WHEREAS, the replacement of these walls has become cost prohibitive to the homeowners;

THEREFORE BE IT RESOLVED:

That staff be directed to review the feasibility of providing a one-time grant to offset the substantive costs of repairing the retaining wall along Guildwood Drive, Hamilton, to home owners and report to the Audit, Finance & Administration Committee.

Councillor Whitehead reassumed the Chair.



SUBJECT: Ancaster Transportation Master Plan and westbound access to Highway 403 in Hamilton

This letter is further to the staff-level meeting on April 8, 2011, between the City of Hamilton and the Ministry of transportation's staff (MTO) regarding the Ancaster Transportation Master Plan and subsequent analysis and operational study conducted by iTRANS Consultants on westbound access to Highway 403 in Hamilton at Golf Links Road, at Mohawk Road and at Main Street.

The City of Hamilton Council approved the following resolution at its meeting on April 27, 2011, regarding the Ancaster Transportation Master Plan:

Ancaster Transportation Master Plan (PW11027) (Wards 1 & 12) (Item 7.1):

- (a) That the General Manager, Public Works Department, be authorized and directed to file the Ancaster Transportation Master Plan (ATMP) report with the Municipal Clerk for a thirty (30) day public review period;
- (b) That upon the completion of the thirty (30) day public review, the General Manager, Public Works Department, be authorized and directed to include the recommended projects for the purpose of future capital budget submissions in conjunction with the phasing identified, provided no comments or Part II Order requests are received that cannot be resolved;

- (c) That the Ministry of Transportation (MTO) be advised of the City of Hamilton's concerns with respect to the capacity deficiency currently being experienced and forecast for Highway 403 between Highway 6 and "New Highway 6" in Hamilton and that improvements proposed through the previous MTO studies for this corridor be implemented;
- (d) That the General Manager, Public Works Department, be directed to request the MTO to expedite the review and approval process of the "Traffic Operational Analysis of Highway 403 at Golf Links Road and Aberdeen Avenue" completed by the City of Hamilton for the proposed ramps at Golf Links Road and Aberdeen ramp;
- (e) That the petition from the Ancaster residents, received by the Mayor's Office February 4, 2011, and considered by City Council on February 23, 2011, Item 5.1, and included as Appendix "E" of this report, requesting a 90-day extension to the Ancaster Transportation Master Plan Study, be received with no further extension of the planning process;
- (f) That the recommended projects, attached as Appendix "A" to Report 11-006 be approved as amended;
- (g) That the preferred solution of a roundabout at the intersection of Wilson Street and Jerseyville Road be elevated to a Schedule C project in conjunction with the Wilson Street improvement project;
- (h) That the preferred solution of a roundabout at Rousseaux Street and Wilson Street not be considered in the current Ancaster Transportation Master Plan;
- (i) That the City continues best efforts to encourage the MTO to construct west bound access to the 403 at Main Street West in Hamilton and Mohawk Road or as an alternative Golf Links Road in Ancaster;
- (j) That the preferred improvements for McNiven Road between Golf Links Road and Mohawk Road be elevated to a Schedule C project;
- (k) That two pedestrian crossings be provided on Wilson Street during Phases 3 & 4 of the Municipal Class EA process for the Wilson Street project

As the MTO has indicated that they are in agreement with the work completed to date with regard to the conceptual aspects of ramps, subject to a number of additional steps including detailed design, risk analysis, micro-simulation, and the Environmental Assessment (EA) process In order to proceed with these further steps for additional westbound access to Highway 403, please indicate which MTO staff we should be in contact with to review the details of the next steps with regard to point (i) above?

We have also attached the following additional information related to this matter:

1. An e-mail dated February 4, 2011, from the MTO regarding their opinion of a westbound access to Highway 403 at Mohawk Road;

Subject: Ancaster Master Transportation Plan and Main St Ramp

Hi Philip,

We are still working cooperatively with Hamilton on both the Golf Links Rd WB Hwy 403 on-ramp, and the Main Street/Aberdeen ramp connection. Both these studies are ongoing, but to date MTO has not agreed in principle or otherwise to allow either of these projects to proceed if the study cannot completely satisfy MTO's concerns. To date, we have not received any detailed analysis or traffic modeling for the Golf Links Rd on and off ramps as requested back in 2009. In addition, we have the following comments:

- For Mohawk on-ramp to Hwy 403 WB, the PIC slides (pg 11) say there is "no support from MTO". That is incorrect. In fact, MTO prefers this alternative to new ramps at Golf Links Rd for several reasons. Golf Links has geometric design issues and diverts traffic through residential neighbourhoods, whereas a WB ramp at the 403/Linc/Mohawk Rd IC would complete the interchange and is more consistent with the expectation from the travelling public for highway access.
- The study's recommendations for new ramps at 403/Golf Links Road is inconsistent with public's general comments (desire for improved transit service, reduced traffic speeds, improved pedestrian environment, continued look and feel of historic small town, don't want more traffic or widened roads. The Golf Links Road scenario scored relatively negative in the transportation category of the evaluation.
- The Ministry will be providing a separate response to the Hwy 403 WB Access study. If you have any questions, please feel free to contact me.
