1. **Infectious Disease and Environmental Health Semi-Annual (BOH16039) (City Wide) (Item 5.1)**

- (a) **Co-location of Solo Family Practices in the Family Health Organization**

4. Public Health Approach to Revising the Legal Framework for Cannabis (Marijuana) (BOH16021) (Item 7.2)

(Farr/Whitehead)

- (a) That the Board of Health support a public health approach to revising the legal framework for recreational cannabis use. This approach combines the public health principles of prevention, harm reduction, treatment and enforcement with strict regulations on the production, distribution, promotion and use of cannabis, with the goal of minimizing the harms from cannabis use;
- (b) That the Board of Health advocate to the federal and provincial governments for strict regulations on cannabis, including the ten recommendations in the Centre for Addiction and Mental Health's Cannabis Policy Framework:
- Set a minimum age,
 - Limit availability,
 - Curb demand through pricing,
 - Curtail higher-risk products and formulations,
 - Prohibit marketing, advertising and sponsorship,
 - Product information should be clearly displayed,
 - Establish a government monopoly on sales,
 - Address and prevent cannabis-impaired driving,
 - Enhance access to treatment and expand treatment options, and
 - Invest in education and prevention; and
- (c) That the Board of Health share report BOH 16021 – Public Health Approach to Revising the Legal Framework for Cannabis (Marijuana) with the Honourable Prime Minister of Canada, local Members of Parliament, the Premier of Ontario, local Members of Provincial Parliament, Minister of Health and Long-Term Care, Federal Minister of Health, Attorney General, Chief Medical Officer of Health, Association of Municipalities Ontario, Association of Local Public Health Agencies, Ontario Boards of Health, and Ontario Public Health Association.

5. **Supervised Injection Sites: Evidence and Proposed Next Steps (BOH16037)
(Item 7.3)**

(Green/A. Johnson)

- (a) That staff be directed to bring a request through the 2017 capital budget process for a needs assessment and feasibility study for one or more supervised injection sites in Hamilton, including but not limited to:
 - (i) Technical and any other data needed to support an application for exemption under the *Controlled Drugs and Substances Act* (e.g., data on drug use, infectious disease rates and other risk factors, rates of overdose, crime statistics, drug-related litter),
 - (ii) Data on potential impact, including potential health, social and community impacts and anticipated cost-effectiveness and/or cost-benefit,
 - (iii) Feedback from stakeholder and community engagement, ***with a greater emphasis on areas that might potentially house a Safe Injection Site,***
 - (iv) Recommendations on whether or not a supervised injection site or sites should be opened in Hamilton, and if a recommendation for one or more supervised injection sites in Hamilton is made, the recommended number of supervised injection sites, geographical location(s), and model type (integrated, standalone, or mobile), and
 - (v) Details of how the requirements for the application process to apply for an exemption under the *Controlled Drugs and Substances Act* will be met;
- (b) That staff be directed to conduct a survey prior to the 2017 budget deliberations to seek general feedback from the Hamilton community on supervised injection sites; and, ***engage and communicate with constituents in those areas that might potentially house a Safe Injection Site, in future; and,***
- (c) That this report fulfils the request of the motion made at the Board of Health meeting on February 18, 2016 "that staff be asked to report back to the Board of Health on the use and effectiveness of safe injection site programs across the country".

6. Sale and Display of Drug Paraphernalia in Convenience Stores Licensed as Food Premises (BOH16022) (Outstanding Business List Item) (Item 8.1)

That the upcoming Business Licensing By-law 07-170 rewrite will include an amendment banning the visual display and promotion of drug paraphernalia and also prohibiting the sale of these items to anyone under the age of 19 years in convenience stores, licensed as food premises.

7. Naloxone Expansion Feasibility (BOH16036) (Item 8.2)

(Green/Whitehead)

- (a) That staff expand naloxone distribution by increasing staffing by 2.0 FTE outreach workers and 1.0 FTE Public Health Nurse to provide access to naloxone at more program sites. This includes expanding Public Health Services' needle syringe van by four additional hours per day, including a new eight hour shift on Sundays (32 additional hours per week) with a cost of \$260,956 to be referred to the 2017 operating budget process;
- (b) That Council send a letter to the Ontario Minister of Health and Long-Term Care with copies to the Chief Medical Officer of Health and all Ontario Boards of Health to request adequate financial resources to support the distribution of naloxone, including distribution through provincial detention centres; and,
- (c) That this report fulfils the request of the motion made at the Board of Health meeting on June 13, 2016 that "Public Health Services report back to the Board of Health on the feasibility of expanding the City of Hamilton's existing Take Home Naloxone Program".

8. Secondment of City of Hamilton Alcohol, Drug and Gambling Services Staff to Towards Recovery Clinic (BOH16043) (Item 8.3)

- (a) That the Board of Health authorize and direct the Medical Officer of Health to receive, utilize and report on funding from the Towards Recovery Clinic for a 0.1 full time equivalent social work position in the Alcohol, Drug & Gambling Services program, and execute a secondment agreement between the City of Hamilton and the Towards Recovery Clinic for a six month pilot project, with a renewal option, satisfactory in form to the City Solicitor; and,
- (b) That the Board of Health authorize and direct the Medical Officer of Health to increase the complement in Alcohol, Drug & Gambling Services program by 0.1 full time equivalent, for the term of the secondment pilot agreement and the time of renewal.

 - Be cost-effective
 - Be successfully accepted by people who inject drugs, local residents, and the police
- Safe Injection Site have not been shown to:
 - Shift drug use to different neighbourhoods
 - Increase drug injecting
 - Increase drug trafficking or crime in the surrounding area
 - Decrease the overall number of people who inject drugs
- Safe Injection Sites in Canada
- Recommended Next Steps
