Laura Cattari, of the Hamilton Roundtable for Poverty Reduction, addressed the Board respecting BOH16050, Nutritious Food Basket 2016, with the aid of a PowerPoint presentation. Pamphlets from the Hamilton Roundtable for Poverty Reduction were distributed and a copy has been included in the official record. Her comments included but were not limited to, the following:

- What is Bill 6, Ministry of Community and Social Services Amendment Act, (Social Assistance Research Commission), 2016
- What does it look at in terms of adequacy?
- What is the ask?
 - That the Board of Health correspond with the Premier of Ontario, Minister Responsible for the Poverty Reduction Strategy , Minister of Community and Social Services and Minister of Health and Long-Term Care regarding the urgent need for income responses to food insecurity and supporting the establishment of a Social Assistance Research Commission
 - The the Board of Health correspond with the Association of Municipalities of Ontario asking for their support in establishing of a Social Assistance Research Commission.
- A quick note from our friends in Niagara
 - Dental Health for Adults and Seniors - Lori Kleinsmith, Health Promoter, Bridges Community Health Centre has asked that we support further provincial funding of expanded oral health

programs with consideration given to adults and seniors who are low income.

- The specifics:
 - Endorse the importance of oral health and request that the Premier of Ontario include oral health as part of the government's primary care transformation initiatives, and further,
 - That Council call on the provincial government to expand public oral health programs with prime consideration for low income adults and seniors, and further,
 - That Council forward copies of this resolution to the Premier of Ontario, the Minister of Health and Long-Term Care, Local Members of Provincial Parliament, Member Municipalities, and the Association of Municipalities of Ontario.

Anne Newbigging, of the Social Action Committee (SAC), Association of Social Workers, addressed the Board respecting BOH16050, Nutritious Food Basket 2016. Her comments included but were not limited to, the following:

- The SAC congratulates Public Health Services on the work they have done in producing the NFB Report for 2016
- This Report and its predecessors have shown us each year that people receiving social assistance in Ontario can barely survive on the amounts set by the Ontario Government
- Although the rates have been raised by 1% per year since 2003, inflation for food and accommodation is closer to 2% per year, so recipients have been falling further behind each year
- The worst case scenario, as shown in Appendix C to the Report, is for single people receiving Ontario Works, who are \$104 short each month of being able to buy nutritious food, after paying an average rent for a bachelor apartment
- Many people think that people receiving Ontario Works are employable and should be moving back into the workforce; but there are many recipients who are physically or mentally unprepared for this
- The SAC, in partnership with Grace Lutheran Church, has been providing a monthly box of fresh fruit and vegetables (a Good Food Box) to OW Singles for the past 2 years, and have met many people who are not able to work
- At present, a private member's bill (Bill 6) initiated by Paul Miller, MPP for East Hamilton & Stoney Creek, is being considered by the Standing Committee on Social Policy of the Provincial Government: this Bill

would create a Social Assistance Research Coalition to study the cost of living in various Ontario communities and recommend social assistance rates that would allow recipients to live decently

- The SAC would like the BOH to urge the Government to pass this legislation, that would lead to more realistic rates of social assistance, so our citizens can buy nutritious food and meet some of their other basic needs

- Each year, Public Health brings forward the Nutritious Food Basket Report, and each year, people on assistance are shown to be falling further behind in access to secure food
- A Basic income system, as Public Health states in their report, would help address food insecurity
- The insecurity and continual stress caused by insufficient income is a major contributor to mental health challenges
- We support Public Health's Nutritious Food Basket report

- We represent six clubs with over 5000 members in Ontario
- Our club advocates for the betterment of women and children
- We support the Nutritious Food Basket report
- We support the establishment of a Social Assistance Research Commission

- We are here to specifically advocate for single persons with Ontario Works and their issues finding and keeping affordable housing

Alana Baltzer, Hamilton Organizing for Poverty Elimination Group, addressed the Board respecting BOH16050, Nutritious Food Basket 2016. Her comments included but were not limited to, the following:

- As a member of Hamilton Organizing for Poverty Elimination, I would urge the Board of Health that Social Assistance rates do not allow unattached recipients to eat a nutritious diet
- Current Social Assistance does not cover rent, nutritious food, and other necessary items
- This does not include toiletries, over the counter medications, or clothing
- The Commission would be able to provide information to the public on Social Assistance Rates and expenses, to give them a clearer picture of the gap in assistance and expenses
- We would recommend that the Board of Health provide written submissions to the Standing Committee for Social Policy to ask them to move ahead with Bill 6, *Ministry of Community and Social Services Amendment Act (Social Assistance Research Commission)*, 2016

Sally Palmer from the McMaster Community Poverty Initiative, addressed the Board respecting BOH16050, Nutritious Food Basket 2016. Her comments included but were not limited to, the following:

- The McMaster Community Poverty Initiative (MCPI) congratulates the PHS staff for their excellent report on the Nutritious Food Basket for 2016

- Bill 6, *Ministry of Community and Social Services Amendment Act (Social Assistance Research Commission)*, 2016 addresses the inadequacy of our present social assistance rates
- If passed, Bill 6 would establish a Social Assistance Research Coalition to research the cost of living in various Ontario communities and recommend rates of social assistance consistent with their findings
- Social assistance for people who depend on *Ontario Works* or the *Ontario Disability Support Program* has been losing its buying power since 1995, when the Ontario Government cut assistance rates by 21.6% for all recipients
- We ask that the Board of Health communicate with the Province regarding the urgent need to move Bill 6 into legislation, to address this critical gap in our services to vulnerable people
