THE GOVERNANCE SUBCOMMITTEE PRESENTS REPORT 16-003 AND RESPECTFULLY RECOMMENDS:

- 1. Disclosure of Council Expense Details (FCS16041) (City Wide) (Outstanding Business List "P") (AF&A Report 16-010 Item #3) (Item 8.1)

- Additional information to include in the review:
 - Phone calls how many times the same number is calling, or a ward is calling out and requesting call backs
 - Tabulation of emails an average/month or week
 - Social Media activity
 - Walk-ins / visits at City Hall and constituency offices
 - Meetings regarding:
 - Business Improvements Areas
 - Commercial, Office and Retail Outlets
 - Parking Interactions
 - Public Meetings city-wide, and within the ward
 - Multicultural Organizations

- Organizations dealing with homelessness and housing
- Ontario Works issues
- Ontario Disability Support Program issues
- Political and Social Justice Activists
- Daily administrative meetings
- Daily meetings requests
- Mail intake / Correspondence
- More information required regarding transient populations, including students
- Clearer reflection of budget allocation going towards part-time staff

(iii) Bill 8 – Ontario Ombudsman's Expanded Authority (LS16023/CL16012) (City Wide) (Item 8.3)

Janice Atwood-Petkovski, City Solicitor, addressed Committee and provided an overview of Report LS16023/CL16012 respecting Bill 8 – Ontario Ombudsman's Expanded Authority, with the use of a PowerPoint presentation. A copy of the presentation has been included in the public record. Her comments included, but were not limited to the following:

- Bill 8 in force January 1, 2016
- A wide variety of ad hoc and formal complaint investigation processes
- Complainants can currently go to City Department/Division staff to complain, or complain directly to Ontario Ombudsman's office
- Inquiries from Ontario Ombudsman office being fielded 'ad hoc'
- To date, Ontario Ombudsman has received 2000 municipal complaints since January 2016
- Ontario Ombudsman strongly encouraging all municipalities to put local complaint mechanism in place
- Option 1: City-appointed ombudsman
- Option 2: Centralized Automated Complaint Resolution Process
- Option 3: De-Centralized Complaints Resolution (Status Quo)
