RECOMMENDATION

- (a) That effective January 1, 2017, an advance of funds be provided to the organizations specified in the attached Appendix "A" to Report GRA16011; and,
- (b) That any outstanding arrears due to the City of Hamilton by the organizations (as shown in the attached Appendix "A" to Report GRA16011) be first applied against the approved grant funding, including advances, until the debt is satisfied, prior to that organization receiving the balance of any approved payment.

EXECUTIVE SUMMARY

In 2015, Council approved the launch of the new City Enrichment Fund. As such, specific organizations that were included in Boards & Agencies, and historically provided advances, were transitioned over to the new program. It was considered that an advance should be provided to the historical funded groups to avoid undue hardship to their operations.

For the organizations listed in the report (attached as Appendix "A" to Report GRA16011), the City follows a policy which ensures that grant payments are not made until outstanding arrears owing to the City of Hamilton are paid off first.

Financial: There are no financial implications associated with providing advance payments to the listed organizations (attached as to Report GRA16011). Pending Council approval of the 2017 funding levels, the remaining payments to these organizations would be adjusted to ensure that the payment amounts do not exceed the 2017 Council approved funding level, which is expected by June 2017.

HISTORICAL BACKGROUND (Chronology of events)

The City has been supporting various Boards and Agencies with grant funding in the past. Since these organizations depend on the City for funding their operational expenditures, past practice has been to continue to support them with regular on-going funding pending the approval of the City Budget for each year. The proposed payment schedule closely follows that of 2016.
