WHEREAS the AGCO requires a separate written notice from the Council of the Municipality within which the applicant's manufacturing site is located confirming that it has passed a resolution in support of the issuance of a Manufacturer's Limited Liquor Sales License for wine (cider),

THEREFORE BE IT RESOLVED:

That Council confirms their support for the issuance of a wine/cider manufacturing licence for Collective Arts Brewing Limited located at 207 Burlington St. E., Hamilton.
