## 7. Hamilton Future Fund Board of Governors Report 16-003, October 13, 2016 (Item 8.6)

- (a) That, as the application submitted to the Hamilton Future Fund, by the Troy/Lynden Branch of the Federated Women's Institute of Ontario, respecting a Building Restoration Project in the amount of \$412,000 was not denied, but was amended to provide a much smaller amount of funding, Item 7 of the General Issues Committee Report 16-028 be amended by deleting sub-section (I) (xvi), which reads as follows, in its entirety:
  - (I)(xvi) Troy/Lynden Branch of the Federated Women's Institute of Ontario respecting a Building Restoration Project in the amount of \$412,000;
- (b) That sub-section (i) of Item 7 of the General Issues Committee Report 16-028, be deleted in its entirety and replaced with the following in lieu thereof:
  - (i) That the application from the Troy/Lynden Branch of the Federated Women's Institute of Ontario be approved for the installation of an accessible ramp in the amount of \$28,000;
  - (i) That \$78,125 of the \$412,000 application from the Troy/Lynden Branch of the Federated Women's Institute of Ontario, respecting a Building Restoration Project, be approved for the following projects:
    - (1) Installation of an accessible ramp in the amount of \$28,000;
    - (2) New heritage windows (includes painting and installation) in the amount of \$21,040;
    - (3) Clapboard siding repairs (includes scraping, caulking, heritage paint and sealant) in the amount of \$21,085; and,
    - (4) Buried hydro lines from the pole into the building, new entrance box and meter in the amount of \$8,000.
