(i) Dr. Deanna Behnke-Cook, IDEAs Program, respecting Informed Decisions Empowering Adolescents (IDEA's) (BOH16059) (Added Item 6.1)

Dr. Deanna Behnke-Cook addressed the Board respecting Informed Decisions Empowering Adolescents (IDEA's) (BOH16059), with the aid of a PowerPoint presentation. A copy of the presentation has been included in the public record. Information packages were distributed to the Board. Comments included, but were not limited to the following:

• The IDEAs Program has been running since 1998

- HWDSB and the HWCDSB have piloted the IDEAs program
- The intent of the IDEAs program is to help young people achieve optimal health now and in the future
- IDEAS is not just a transition program
- Students want to speak with Peer Mentors to answer their questions and work with them as they transition into upper levels of education
- The program allows for students academic engagement, whatever that means to each student
- Drugs and alcohol, and sexual activity are a real part of students lives
- Students need to be supported so that they know how to avoid these situations
- There are not enough Public Health Nurses to reach all these students
- We need young men to hear from young men, and young women to hear from young women
- Peer mentoring makes the information real to the students
- The IDEAs program addresses 2017 Ontario curriculum expectations

- I loved the program, the students loved the program, and commented on it for many years afterwards
- Now, as Director of Family Ministry, I deal with six school boards, working on the health and physical education programs
- I invited school board Directors to hear about the IDEAs program
- From my point of view, the Hamilton Wentworth Catholic District School Board is in favour of the IDEAs program
- We have a better chance of helping students in their transitional period between childhood and adulthood with programs like IDEAs

- I have been a teacher in the Hamilton Wentworth District School Board, working specifically in health and physical education for 30 years
- I first met Dr. Benhke-Cook early in my career when she came to speak on AIDS prevention
- Her program is irreplaceable, and invaluable
- She helped me develop my peer mentor program
- The message to my students is "Every day is a new day"
- The peer mentors spread their knowledge to the rest of the students
- Dr. Benke-Cook is recognizable and known for her program throughout the school
- The students are not comfortable going to the Public Health Nurse for their questions
- The students go to the Peer Mentors with their questions and concerns
- The IDEAs program is worth more that the \$50k in the Public Health Budget

- We had an event at Delta Highschool in November, where we invited the Grade 8 students from feeder schools to come and spend the day with us going to classes
- My name is Sophia Xhekaj, and I received a message from a student we mentored telling us how much she learned and how helpful the IDEAs program was to her during a time of loss in her family
- Our group is very diverse, including students from every facet of life
- My name is Michaela Hallok, and I'm a Senior at Delta Highschool
- This program means a great deal to me because of my own personal challenges

- The IDEAs program has taught me that I am not alone in my struggles and that I can make a difference through my experiences
- My name is Sarah Gunell, and I'm in Grade 12
- The IDEAs program is important to young students because of our diversity and our ability to speak to them as peers
- The messages of personal safety are important for them to hear from people their own age

Patty Aragian, Hamilton Wentworth District School Board, addressed the Board respecting Informed Decisions Empowering Adolescents (IDEA's) (BOH16059). Her comments included, but were not limited to, the following:

- I am a physical and health education specialist for my entire teaching career
- I have seen and heard of past students who end up making poor choices related to substance use and engaging in early sexual behaviours that have led to negative outcomes such as unwanted pregnancy
- I have had the opportunity to see the IDEAS program in action over many years
- This peer mentor intervention program is priceless within my school community
- The IDEAS program educates our students and gives them a forum to ask relevant questions regarding their concerns and fears which are uniquely connected to themselves and the community they belong to
- I can guarantee you that many of these inner-city kids have witnessed more negative behaviours thus far in their young lives than all of the adults combined in this room
- The IDEAS program and it's mentors are living proof that the vicious cycle of early substance use, premature sexual activity and academic failure is not their destiny, because believe me, many of my students think that it is inevitable, that this will be their future
- From my extensive experience in this field, I can honestly tell you that regardless of my passion for what I do, the level of classroom discussion during the IDEAS sessions supersedes the level of participation that is elicited in the regular classroom lead by me
- I am a true advocate for this program and hope that you will see the value of it, as I am sure it has impacted many of my students

 - Complex issue needs a community approach –focus on high social risk factors as place to start
- Youth Leadership
- Care Pathway Approach
- Youth Pregnancy Care Pathway for Care Providers
- Young Parent Resource Tool
- Building Capacity through Cross-sector Education
- Best Practice Smoking Cessation Supports Sustaining and leveraging impact towards new goals
- Informing system integration initiatives
- Aligning with other strategies and networks
- Care Pathway, Cross-sector Education, and Smoking Cessation integrated into operational programming
- Next Steps
 - Ongoing monitoring and evaluation
 - Youth Sexual Health Strategy
 - Cross-divisional collaboration focused on youth wellbeing
 - Build on community partnerships and HBW success
