THE FOLLOWING ITEMS WERE REFERRED TO COUNCIL FOR CONSIDERATION:

1. Hosting of Future Grey Cup Game (PW16110) (Ward 3) (Item 5.1)

(Merulla/Eisenberger)

That staff be directed to encourage the Canadian Football League to host the 2019 Grey Cup at Tim Horton's Field in the city of Hamilton, or as per the Agreement, with no impact on the general levy.

Judy Travis and Tom Cooper, addressed Committee respecting Living Wage. The presentation included, but was not limited to, the following:

o Provincial minimum wages aren't cutting it. They are arbitrary, politically derived figures – not based on evidence and not coming close to meeting the actual cost of living in Canadian communities. As a result, more and more individuals and families are slipping into poverty as minimum wages fail to keep pace with the cost of living.

- o The modern living wage movement started in Baltimore, Maryland in the early-1990s and has since spread across many countries. Living wage initiatives are particularly active in the English-speaking world.
- o In the United States, grassroots campaigns have focused on encouraging municipal governments to adopt living wage policy for both direct full and part-time workers, as well as requiring companies that contract with the City to pay their employees a living wage.
- o Today, living wage ordinances cover more than 150 jurisdictions in the United States, including New York City, San Francisco, Chicago, Los Angeles and Seattle. In May, Los Angeles City Council voted to increase its minimum wage from \$9 per hour to \$15 per hour.
- o New York City's living wage procurement policy will impact 18,000 low-wage workers. As New York Mayor Bill de Blasio noted last September: "We cannot continue to allow rampant and growing income inequality. Every tool counts."
- o In the United Kingdom, London Citizens, a non-governmental, grassroots organization, launched the Living Wage Foundation in 2001. Led by a group of parents in the East End of London, the Living Wage Foundation found success in engaging private sector employers who were committed to the moral and business value of adopting living wages for their employees.
- o Nearly 3,000 large and small British employers including furniture retailer IKEA, food giant Nestle, financial services employer KPMG and the Chelsea Football Club are accredited living wage workplaces.
- o Scotland's living wage campaign has focused on engagement of public sector employers. Through the leadership of anti-poverty organizations and Scotland's labour movement, most public sector employers in Scotland: universities, school boards and local authorities are now accredited living wage employers, including the Scottish parliament.
- o The Aotearoa (New Zealand) Living Wage campaign launched in 2013 and the Republic of Ireland calculated a living wage in 2015.
- o Living wage initiatives are guickly emerging in Canada.

o Living wage rates vary from community to community as costs for things like housing, food, transportation and child care availability changes. These are evidence based calculations based on what it actually costs to live and participate in these communities.

- o A stable, productive workforce more than pays for the additional cost associated with living wage, there is less employee theft, less absenteeism, more productivity and the money goes back into the local economy.
- o You will also notice an increase in "discretionary effort" given by employees; their willingness rather than their obligation to do their best when they feel valued.

(xiii) Tom Atterton on behalf of Antony Marco, Hamilton and District Labour Council, respecting Hamilton's Living Wage (Item 6.13)

Tom Atterton addressed Committee on behalf of Antony Marco, Hamilton and District Labour Council, respecting Hamilton's Living Wage. Mr. Atterton's comments included, but were not limited to, the following:

o The 40,000 affiliated members of the Hamilton and District Labour Council come from local unions both large and small, and represent work forces ranging from emergency rooms to classrooms, from assembly lines to power lines, and from concert halls to City Hall.

- o Many, though admittedly not all, union workers enjoy wages that meet Living Wage standards in the cities they live in. On average, union members earn \$5.28/hour more than workers without a union, and, for women, this number jumps to \$7.10/hour. Young workers who are part of a union earn an average of \$3.74/hour more.
- o The reason I bring up this statistics is because when unions stand up for Living Wage, they are not doing so out of self-interest. We believe that poverty is one of the greatest equity problems people face and, further, we believe situations of working class families struggling in poverty can be remedied through social policy.
- o There are several movements trying to raise the minimum wage and, quite frankly, we support all of them. The reason we like a Living Wage is the built in ability to re-evaluate and re-assess the needs of workers on a regular basis if the cost of living dramatically changes.
- o We are asking Council to take the step of becoming a Living Wage employer and ensure that all full-time, part-time, and casual employees of the City of Hamilton receive a wage of at least \$15.85 cents an hour.
- o Most City employees, through hard-fought collective bargaining, are already there.
- o For those who aren't, we would ask Council to consider the following value proposition: what does this further investment in workers do for the City?
- o First, it allows the City to become branded as a Living Wage employer. Such branding not only brings talent to these jobs, but also retains employees lost through attrition as they search the next opportunity that might pay a few cents more per hour. Your seasonal employees will be back next season and save you time and money on training because they know a living wage can help give them extra time with their families or help pay for tuition.
- o Second, it starts to put more buying power out into the community. The worker who goes from minimum wage to living wage is not stashing that money in an overseas bank account; they are spending it locally. As larger employers start to agree to become Living Wage employers, the purchasing power by consumers in a city goes up, spurring spending and job growth.

- o I can't emphasize this last one enough, as employers you should be concerned about your employees living in poverty.
- o If Hamilton is the best place to raise a child and age successfully. employees of the City should not be part of the working poor.
- o If Hamilton is committed to provide high quality, cost-conscious public services that contribute to a healthy, safe and prosperous community, in a sustainable manner, I would ask you to consider that being "cost-conscious" should not simply mean cheapest. There is a human cost to your employees being part of the working poor. What better way to invest in a healthy, safe and prosperous community than modelling a commitment to allow for your own employees to feed themselves and their families?
- o There is a cost becoming a Living Wage employer and there is a value. For the value side, I would ask that Council consider the happy prospect of your employees feeling financially secure in their choice to work for you instead of worrying where a second job is going to come from. I would argue the cost in choosing to not become a Living Wage employer involves fostering a group of working poor employees, precariously living from paystub to paystub.
- o This is an investment into your most precarious and vulnerable staff. This is an opportunity to show large employers across the city that some costs are human costs, and workers, be they full-time, part-time, or casual are valued and should be proud to say "I work for the City of Hamilton".

- o Nearly 5 years ago, when Hamilton first determined a living wage for workers in this city our Bishop returned from a meeting of the Hamilton Roundtable for Poverty Reduction committed to reviewing our policies to ensure that we were paying our diocesan employees a living wage.
- o This was in keeping with a commitment flowing from our diocesan vision to be a leader in the community we serve.
- o When began our review, we were in a situation similar to that facing the City of Hamilton today; whereby all our salaried, full-time

- employees were earning a living wage, but very few of our hourly employees were.
- o We believe that ensuring fair and living wages for our staff is important; for it speaks to our belief that God has provided enough for all, and to our call to share those resources in a way in which all people can flourish with dignity.
- o Deeply aware that staff compensation accounts for a large part of institutional and civic budgets each year, and that there are always a variety of challenges to make ends meet. But we, along with over thirty organizations in this City, have recognized that at the very least we have a responsibility as employers and community leaders to ensure that all our employees receive a wage that lifts them above the poverty line.
- o I am proud to say that five years after our initial conversation about living wage all of our diocesan employees are already earning the revised living wage of 15.85/hr.
- o Our encouragement is two-fold:
 - First, that you look at this matter through the lens of the City's vision; and,
 - Second, to embrace the immense leadership role you have as not only our local government but as a leading employer.
- o When living wages are paid, human dignity is enhanced, communities are healthier and everybody can share in the abundance of this incredible City.
