### (i) Housing and Homelessness Advisory Committee 2017 Work Plan (Item 5.1)

Discussion about major topics the committee would like to see presentations on in 2017. The group discussed aspects of the action plan and where they required more information and could see opportunities for increased discussion.

Main areas were:

- Bed bugs:
  - Costs of the program and other supports
- Incentives
  - Incentive packages and inclusionary zoning
- Development
  - Market rate development (#s) vs affordable housing developments
  - Vacant lands policy for affordable housing developments
  - Interest rates, CMHC, how these impact affordable housing developments.
  - o Equity and debt financing for development
- Social Housing vacant units
  - how many, information on service providers asset management plans
- Social Housing Waitlist
  - Picture of whose on the waitlist (demographic info, families, singles, children etc.)

- RCF's
  - RCF's, private vs non profit operations
- Supports for tenants dealing with Landlords
- Information on the Point in time count
  - Shelter system, housing first programs and other supports
  - o Womens Shelter system
  - Education and Outreach, how are people being transitioned to homes
- Living wage and guaranteed minimum income supports (general financial supports) helping break the cycle of poverty
- Social housing agreements/various forms of social housing operating agreements
- Secondary suites planning issues, illegal units, legalization, current rent estimates, impact on affordable housing
- West Harbour and affordable housing
- Budget \$'s, funding for housing, Federal/Provincial/Municipal operation and Capital investments
