(a) That City Council support the naming of the outdoor community gathering area, within the McQuesten Urban Farm, as the "Patricia Reid Community Gathering Place"; and,

- (c) That the General Manager of the Planning and Economic Development Department be authorized to approve and execute any grant amending agreements, together with any ancillary amending documentation, if required, provided that the terms and conditions of the Environmental Remediation and Site Enhancement (ERASE) Redevelopment Grant, as approved by City Council, are maintained.

## 7.4 Federal Infrastructure Phase 2 Incrementality

#### (Eisenberger/Partridge)

WHEREAS, municipal governments' infrastructure is critical to our collective economic health:

WHEREAS, stable, predictable and formula-based infrastructure funding allows municipal governments to plan and schedule investments in infrastructure;

WHEREAS, Ontario municipal governments have asset management plans which set out a municipality's longer term capital plan which reflects the infrastructure priorities of these asset management plans; and,

WHEREAS, a federal incrementality rule interferes with municipal long-term infrastructure priorities and diminishes the value of municipal asset planning and management;

WHEREAS, it is very difficult to complete the capital projects within the allotted one year time line;

NOW THEREFORE BE IT RESOLVED:

- (a) That the City of Hamilton calls on the federal government to provide longterm, predictable, and formula-based funding in its Phase 2 programs for municipal governments; and,
- (b) That the City of Hamilton calls on the federal government to change incremental requirements in Phase 2 to recognize in Ontario that a municipal government' asset management plan meets a municipal incremental infrastructure requirement.
- (c) That copies of this resolution be forwarded to AMO and FCM

## 7.5 Niagara Peninsula Conservation Authority Audit

#### (B. Johnson/Merulla)

WHEREAS, the Niagara Peninsula Conservation Authority (NPCA), a Provincial agency operating in the City of Hamilton, Regions of Niagara and Haldimand County, is funded partially by the City of Hamilton;

WHEREAS, the City of Hamilton has asked in the past for the Province of Ontario to review and oversee operations at the NPCA:

WHEREAS, serious questions have been raised about the financial and human resource management of the NPCA;

WHEREAS, serious questions have been raised about the functioning of the NPCA in upholding its duty to fulfill the legislative mandate, as set out for it in Section 20 of The Conservation Authorities Act, "to establish and undertake programs designed to balance the conservation, restoration, development and management of natural resources";

WHEREAS, the City of St. Catharines has unanimously passed a motion asking the Province to initiate an appropriately thorough investigation be it a value for money and/or a forensic audit of the Niagara Peninsula Conservation Authority;

WHEREAS, the Township of Wainfleet unanimously passed a motion; "That Wainfleet Town Council request the NPCA Board to consider obtaining an independent third party audit, such as a value for money audit and/or forensic audit, above and beyond their annual financial audits;

WHEREAS, both Niagara on the Lake and City of Port Colbourne also passed unanimously a motion requesting a forensic audit of the NPCA; and,

WHEREAS, the people of the City of Hamilton, Region of Niagara, Haldimand County and Province of Ontario deserve openness and accountability as to how their tax dollars are being spent and how effectively our natural environment is being protected;

#### THEREFORE BE IT RESOLVED:

That the Mayor, on behalf of Council, send a letter to Premier Kathleen Wynne and Kathryn McGarry, Minister of Natural Resources and Forestry, the Auditor General of Ontario, with copies distributed to the NPCA, all Hamilton and Niagara MPPs, the Niagara Region, local tier municipalities in Niagara, and Haldimand County, urging the Province to immediately initiate an appropriately thorough investigation, be it a value for money and/or a forensic audit of applicable 2012 – 2016 transactions of the Niagara Peninsula Conservation Authority.

## 7.6 One Year Pilot Program for Yard Maintenance Related By-laws in the McMaster Neighbourhoods

## (A. Johnson/B. Johnson)

WHEREAS, a motion to approve one full-time Environmental By-law Officer to enforce the City's by-laws in the communities surrounding McMaster University was TABLED by the Planning Committee on December 6, 2016 to allow the Ward Councillor to investigate alternative funding sources including, but not limited to, Bell Cell Tower Funding and Capital Reinvestment Reserves (Area Rating); and,

WHEREAS, no viable alternative funding sources are available for increased bylaw enforcement in the communities surrounding McMaster University;

#### THEREFORE BE IT RESOLVED:

- (a) That staff be directed to expand the current Mohawk College Co-op Student program by hiring two additional students for enforcement of the one year pilot program for yard maintenance related by-laws in the McMaster neighbourhoods, based on full cost recovery through Fee for Inspection charges for non-compliant properties;
- (b) That, as part of the one year pilot program for enforcement of yard maintenance related by-laws in the McMaster neighbourhoods, the Mohawk College Co-op Students be directed to collect baseline data in order to assist in determining adequate, permanent yard maintenance bylaw enforcement resource requirements for the McMaster neighbourhoods;

- (c) That one Parking Control Officer be redeployed to proactively address parking issues in the McMaster neighbourhoods; and,
- (d) That staff be directed to report back to the Planning Committee before the end of the 12 month pilot program for enforcement of yard maintenance related by-laws in the McMaster neighbourhoods, with the results of the pilot and recommendations for permanent by-law enforcement resource requirements for the McMaster neighbourhoods.

WHEREAS, the City of St. Catharines has unanimously passed a motion asking the Province to initiate an appropriately thorough investigation be it a value for money and/or a forensic audit of the Niagara Peninsula Conservation Authority;

WHEREAS, the Township of Wainfleet unanimously passed a motion; "That Wainfleet Town Council request the NPCA Board to consider obtaining an independent third party audit, such as a value for money audit and/or forensic audit, above and beyond their annual financial audits;

WHEREAS, both Niagara on the Lake and City of Port Colbourne also passed unanimously a motion requesting a forensic audit of the NPCA; and,

WHEREAS, the people of the City of Hamilton, Region of Niagara, Haldimand County and Province of Ontario deserve openness and accountability as to how their tax dollars are being spent and how effectively our natural environment is being protected;

#### THEREFORE BE IT RESOLVED:

That the Mayor, on behalf of Council, send a letter to Premier Kathleen Wynne and Kathryn McGarry, Minister of Natural Resources and Forestry, the Auditor General of Ontario, with copies distributed to the NPCA, all Hamilton and Niagara MPPs, the Niagara Region, local tier municipalities in Niagara, and Haldimand County, urging the Province to immediately initiate an appropriately thorough investigation, be it a value for money and/or a forensic audit of the Niagara Peninsula Conservation Authority.

- (c) That one Parking Control Officer be redeployed to proactively address parking issues in the McMaster neighbourhoods; and,
- (d) That staff be directed to report back to the Planning Committee before the end of the 12 month pilot program for enforcement of yard maintenance related by-laws in the McMaster neighbourhoods, with the results of the pilot and recommendations for permanent by-law enforcement resource requirements for the McMaster neighbourhoods.
