# Formation of a Working Group to Create an Information Source for People with Disabilities Looking for Appropriate Housing

WHEREAS there is a significant gap in the knowledge of accessible and available housing for people with a variety of disabilities in the city of Hamilton;

WHEREAS, the Housing Division of the City of Hamilton does not have a comprehensibe inventory of appropriate housing for persons with disabilities;

WHEREAS, the special needs questionnaire for the coordinated access to housing, currently provided by Access to Housing, does not cover the full

spectrum of disabilties, as defined by the Accessibility for Ontario with Disabilities Act (AODA);

WHEREAS, current information regarding buildings and support services for people with a variety of disabilities is fragmented; and

WHEREAS, the subject of suitability/appropriateness was not discussed in the Seniors' Advisory Committee's "Housing Options for Older Adults in Hamilton":

#### THEREFORE BE IT RESOLVED THAT:

- (a) That a working group be formed to produce a comprehensive information source for people with disabilities looking for appropriate housing for their specific, special needs; and
- (b) That a staff person from the Housing Division be provided to support the working group to liaise with the various housing and service providers in conjunction with the Advisory Committee for Person's with Disabilities.
