## **Urban Forest Strategy (UFS) – Work Plan**

# Work Plan Goal:

To prepare an Urban Forest Strategy (UFS) that will proactively guide the preservation, management, and enhancement of the City of Hamilton's trees and forests on public and privately-owned lands in the urban area for the next 20 years.

#### Objectives:

- 1. To engage stakeholders, agencies, landowners, and the public.
- 2. To review and document current policies, programs, and regulations relating to tree and forest protection, maintenance, and enhancement in Hamilton.
- 3. To recommend future City policy, regulations, programs, and partnerships (actions) to achieve the goals of the Strategy.
- 4. To recommend targets and performance indicators to monitor the Strategy's effectiveness.

# **Strategy Scope:**

The urban forest refers to all trees and woodlands on public and private properties within the urban area of the City of Hamilton.

In consultations with community stakeholders and City staff in the summer of 2015, it was noted that protecting and enhancing tree cover in urban and rural areas requires different approaches. There was a consensus that the Strategy should focus on the urban area, since preserving tree cover in the urban area is considered a higher priority to mitigate the Urban Heat Island Effect / Climate Change impacts, to divert storm water flows, to improve air quality, aesthetics, and overall quality of life. It was concluded that the Strategy should focus on the urban area due to harsher growing conditions and increased benefits that urban trees provide in contrast to rural trees. Therefore, this Work Plan has been prepared for an UFS. After the UFS has been completed, a Rural Forest Strategy will be prepared.
