#### **EXECUTIVE SUMMARY**

This report responds to the following staff direction from the February 8, 2017 Council meeting:

That staff be directed to bring report to the Facility Naming Sub-Committee respecting the renaming of Lawfield Arena to the Bill Friday Lawfield Arena.

# SUBJECT: Naming the Lawfield Arena "Bill Friday Lawfield Arena" (PED17053) (Ward 7) - Page 2 of 4

Mr. Friday was a well-known Hamiltonian with over 19 years officiating hockey, 12 years in the National Hockey League (NHL) and 7 years in the World Hockey Association (WHA). He is also known as one of the best at his craft sharing his refereeing knowledge and experience over his career. Mr. Friday resided around the corner from Lawfield Arena.

The nationally televised Rogers Hometown Hockey Tour is coming to Hamilton's Waterfront Pier 8 on April 8 and 9, 2017 with local celebrations commencing April 6. As part of the planning for this initiative, members of the event's local organizing committee identified the renaming of the Lawfield Arena to the Bill Friday Lawfield Arena as a way to celebrate and recognize Hamilton's hockey history.

As part of the Rogers Hometown Hockey Tour local celebrations, the naming ceremony is being proposed as part of the program to be held on Thursday April 6, 2017.

To date the Facility Naming Sub-Committee has received approximately 10 letters of support from members of the community in support of a naming initiative after Mr. Bill Friday.

#### HISTORICAL BACKGROUND

Bill Friday grew up on the east mountain spending much of his sporting youth playing hockey and baseball.

Mr. Friday is the only referee to ever work the Stanley Cup finals in the NHL and the Avco Cup finals in the WHA. With over 19 years officiating, 12 years in the NHL and 7 years in the WHA, Mr. Friday became known as one of the best at his craft sharing his refereeing knowledge and experience over his career.

A former Junior B and minor hockey league player for Hamilton Aerovox, Mr. Friday worked as an on-ice official in the Ontario Hockey Association (OHA) from 1955 to 1959. He joined the NHL staff the following year and worked games there until 1972.

Mr. Friday is a founder and first president of the NHL Officials Association (NHLOA) and played an important part in its founding. The NHLOA was formed in 1969 out of a need to improve working conditions, salaries and other benefits for officials of the National Hockey League.

In 1973 Mr. Friday joined the newly formed WHA. It was here he officiated the very first WHA game and the very last game the league played in 1979. He was appointed the WHA referee-in-chief in 1976. In 2012 he was inducted into the WHA Hall of Fame. Mr. Friday is also a member of Hamilton Sports Hall of Fame's inaugural class.

Other notable accomplishments include officiating the NHL Stanley Cup Playoffs; NHL All-Star game; NHL All-Star Alumni Game; WHA finals every year from 1973 to 1979; WHA All-Star games and the 1976 Canada Cup.

The naming of an arena or ice surface for Mr. Bill Friday was spearheaded by the Friday family in late fall 2016.

The naming request can be considered as per the City of Hamilton Municipal Property and Building Naming Policy. The request meets the Policy Naming Criteria and Guidelines set out in Section 4 (b) (iii), as detailed in the Analysis and Rationale for Recommendation section of Report PED17XXX.

Council, at its meeting of December 14, 2005, approved Report PW05142/CS05034 to the Facility Naming Sub-Committee regarding the City of Hamilton Municipal Property and Building Naming Policy. The policy serves to establish guidelines and regulations for naming property and buildings owned by the City of Hamilton.

The City of Hamilton Municipal Property and Building Naming Policy has accepted categories from which proposed names of municipal properties and buildings may be selected: geographic, historic, and prominent individuals/organizations (listed in priority order).

The Prominent Individual/Organization category, Section 4 (b) (iii), states that, names affiliated with individuals or organizations may include, but are not limited to individuals who, in voluntary or philanthropic capacity, have made a significant contribution in the area of public service on a local, national, or international scale.

As Mr. Friday made a significant contribution in the capacity of public service on an international scale, the proposed naming meets the criteria under the City of Hamilton Municipal Property and Building Naming Policy.
