The City of Hamilton (The City) is committed to providing a safe, respectful, and inclusive environment for community members who use our services and for all employees. The City has a legal and moral responsibility to maintain environments that are free from discrimination and harassment for community members and employees. The City is committed to enhancing equity and inclusion through the provision of City services and within the workplace, and to promote awareness of our human rights obligations. In accordance with *the Canadian Charter of Rights and Freedom*, the Ontario Human Rights Code (the Code), the City recognizes the dignity and worth of every person such

that each person feels a part of our community and is able to contribute fully without harassment or discrimination.
