#### **Council Direction:**

The General Issues Committee, at its meeting of August 8, 2016 requested "that staff review the feasibility of installing public Wi-Fi as a pilot in Gage Park, to be funded directly from ward specific, non-property tax revenues in the Ward 3 Account #3301609603 (Bell Mobility Cell Tower Revenues), and report back to the General Issues Committee".

#### Information:

The Information Technology Division has determined that providing Wi-Fi coverage for a portion of Gage Park is technically feasible. Financial feasibility will be considered once the Request for Quotation (RFQ) for installation is completed in Q1 2017.

In determining the technical feasibility, several factors have been considered including a) access to a network circuit, b) installation and c) support requirements, as follows:

- a) Gage Park currently has a network circuit which can be leveraged to deliver Wi-Fi traffic. The existing network circuit is used for City staff located at Gage Park. This eliminates the cost of a third party network service provider.
- b) Installation to accommodate the regular daily attendance in the park has been determined to be technically feasible in specific areas of the park including the

horticultural building and The Children's Museum. Wi-Fi coverage to accommodate festival size crowds would require additional consideration. The RFQ will acquire pricing for various coverage scenarios as noted in Appendix "B" to this Report, such as;

- Band shell Area;
- · Splash Pad;
- Pump Track;
- Special events; and,
- Combinations of the above.
- c) Technical support will be provided on a next business day basis. IT will leverage existing Wi-Fi tools to proactively monitor availability and report on usage.

Once the pilot has been operational for six months staff will re-assess usage, usability and coverage as well as review the support model to ensure sustainability of the pilot. This type of hardware has a five year lifecycle, therefore a refresh lifecycle will need to be established with a funding source.

Existing contracts will be leveraged for the procurement of Wi-Fi radio equipment and network data cabling for the pilot.

Once the evaluation of the RFQ is complete IT will determine if the implementation is financially feasible.

A complete list of existing City of Hamilton public Wi-Fi locations is attached as Appendix "A" to this Report. Signage, similar to that placed in Recreation facilities, attached as Appendix "C" to this Report, will be placed in the park to promote the availability of free Wi-Fi.

That the item respecting "reviewing the feasibility of installing public Wi-Fi as a pilot in Gage Park, to be funded directly from ward specific, non-property tax revenues in the Ward 3 Account #3301609603 (Bell Mobility Cell Tower Revenues)", be considered complete and removed from the Audit, Finance and Administration Committee's Outstanding Business List.




