6. Presentations

- 6.1 Hamilton Immigration Partnership Council-Nicole Longstaff, PMP, Senior Project Manager, Newcomer Resettlement Neighbourhood & Community Initiative Division
 - Nicole Longstaffpresented a status update on behalf of the Mayor's Advisory Committee on Syrian Newcomers to the I&R Committee
 - The Update Report was presented to Council on January 23, 2017 highlighting the following:
 - Highest priority advocacy items from Employment, Language and Skills Development Working Group and the Health Working group.
 - Waitlists for English classes, child care and Oral health coverage
 - o Lack of interpreters with experience in medical setting

- Other issues identified for attention: mental health (subgroup established), family reunification, cultural competency (frontline staff/volunteers)
- An evaluation of the Hamilton municipal, community response to Syrian newcomer resettlement is currently in progress. Results of evaluation expected by May of 2017
- N. Longstaff will forward the power point presentation to the committee via the staff liaison
- Councillor Skelly commented that the real issues are housing and jobs. The committee agreed to invite Jo-Anne Priel, General Manager of Emergency & Community Services Department and Dr. E. Richardson, Public Health Department to attend a future Immigrant &Refugee Advisory Committee meeting to share their thoughts on where emphasis and dollars should go with respect to Newcomer Resettlement
- L. Johnson noted that there were consultations hosted by HIPC in 2008by the former Manager, Tim Rees; and similar recommendations were made as being presented. At that meeting in 2008 the participants were told that there was no funding to carry out these recommendations
- The Immigrant & Refugee Advisory Committee is concerned that perhaps these recommendations may not be seriously considered and carried forward?
- N. Longstaff provided the following regarding the most recent recommendations:
 - the Federal government funds refugee newcomers settlement supports (Province funds some as well) and that we are requesting more funding from those bodies (who already provide funding for refugee newcomer resettlement) with the recommendations we put forth from the Mayor's office. There is funding, but we need more of it. Whether there is funding (or not) to carry out the recommendations made depends on the decision of the Federal, Provincial government bodies.
- The members of Immigrant and Refugee Advisory expressed strong interest in having a standing seat of membership on the HIPC
- L. Longstaff concurred that the Committee will have a seat at the Council table.
