Mayor Eisenberger and Council,

Dear Mayor Fred, thank you for the response to my correspondence regarding an LRT review by the Auditor General of Ontario dated 2017-03-20, although, I was very disappointed to receive the standard 'against LRT' template letter.

I write to correct your understanding of my position. I am not against LRT. However, I cannot currently support the \$3-billion 3/4 LRT B-Line due to early decision-making, which has resulted in this 'as-is' program now being unaffordable.

Smart Communities 1.0

If you read the first of my previous seven Our Future Hamilton submissions; Our Future Hamilton - is a Smart Sustainable City dated 2015-08-25 [A], you will learn of my past attempts to bring Smart Sustainable City strategy to Hamilton 17 years ago. It's my renewed goal to make Hamilton the top Smart Sustainable City in Canada, but that challenge will be difficult if the current Council and Administration leads us down the path of possible bankruptcy with the present lack of life-cycle thinking and 'out-dated' practices on LRT.

People and Culture

The people you are relying on to give Council the information to make good decisions do not work to Asset Management-Sustainment Practice. Noteworthy, the public sector and universities do not teach these advanced whole life-cycle AM-SP skills. Important point here it's not the engineers, analysts or managers fault. Staff's current infrastructure Asset Management (AM) efforts are admirable but, are only a good start at innovation. The City of Hamilton is just scratching the surface of the kind of AM practices that are needed to propel Hamilton, Ontario, to top *Intelligent Community* status.

Smart Cities or Communities 2.0

Although I have struggled to get the ear of this City and the Province to date, I do have the ear of the Federal Finance Minister and the Advisory Council on Economic Growth (see Appx A). I have a couple of very exciting big ideas for the *Smart Cities Challenge* in process which will help propel this city towards prosperity. I look forward to sharing them with staff and Council in the near future.
