CHRISTIE CLASSIC ANTIQUE SHOW – SPECIAL OCCASION PERMIT LIQUOR LICENCE

WHEREAS, Hamilton City Council has received Notice (attached hereto as Appendix “A”) from Mr. Brian Book on behalf of the Optimist Club of Strabane, that they wish to obtain approval for a Special Occasion Permit Liquor Licence to sell alcohol on May 27, 2017 between the hours of 11:00 a.m. and 6:00 p.m. at Christie Lake Conservation Area, 1000 Highway 5 West, Dundas, Ontario during the Christie Classic Antique Show taking place in Hamilton, Ontario;
