1. Waste Management System Development - Public Engagement Strategy Results and Preliminary Waste Management System Alternatives (PW16059(b)) (Item 7.2)

- (a) That the public engagement strategy results on the City's waste management services, as outlined in Report PW16059(b), be received;
- (b) That the preliminary waste management system contract extensions as outlined in Report PW16059(b) be approved, which include:
 - (i) The Household Hazardous Waste depot operations contract extension to provide the services until March 31, 2021;
 - (ii) The waste collection services contract extension to provide the services until March 29, 2021;
 - (iii) The City negotiates an extension to the existing contract for the Materials Recycling Facility operations and report back to Council by the second half of 2017 on the outcome of the negotiations including the recommended length of the extension;

- (iv) The City negotiates an extension to the existing contract for the Central Composting Facility operations and report back to Council by the second half of 2017 on the outcome of the negotiations including the recommended length of the extension;
- (c) That staff investigate opportunities for various alternative service delivery methods for the City's waste collection programs for Council's consideration, while retaining the current public/private service delivery model, the weekly collection service and the garbage collection days, and that staff report back by the first quarter of 2018.
