CITY OF HAMILTON

BY-LAW NO. 17-

To Amend By-law No. 01-215 Being a By-law To Regulate Traffic

WHEREAS sections 8, 9 and 10 of the Municipal Act, 2001, S.O. 2001, c. 25, authorize the City of Hamilton to pass by-laws as necessary or desirable for the public and municipal purposes, and in particular paragraphs 4 through 8 of subsection 10(2) authorize by-laws respecting: assets of the municipality, the economic, social and environmental well-being of the municipality; health, safety and well-being of persons; the provision of any service or thing that it considers necessary or desirable for the public; and the protection of persons and property;

AND WHEREAS on the 18th day of September, 2001, the Council of the City of Hamilton enacted By-law No. 01-215 to regulate traffic;

AND WHEREAS it is necessary to amend By-law No. 01-215.

NOW THEREFORE the Council of the City of Hamilton enacts as follows:

1. Schedule 2 (Speed Limits) of By-law No. 01-215, as amended, is hereby further amended by removing from Section "E" (Hamilton) thereof the following item, namely:

South Bend Road	Holt Avenue	Seven Oaks Drive	40

And by adding to section "D" (Flamborough) thereof the following item, namely;

Longyear Drive	Hollybush Drive	Brian Boulevard	40

And by adding to section "E" (Hamilton) thereof the following items, namely;

Dallas Avenue	West Limit	Upper Gage Avenue	40
South Bend Road	Upper Wellington Street	Holt Avenue	40

2. Schedule 6 (One-Way Streets) of By-law No. 01-215, as amended, is hereby further amended by removing from Section "E" (Hamilton) thereof the following items, namely:

John	Northerly	Strachan	Burlington
Hughson	Northerly	Main	Barton
King William	Easterly	James	Mary

And by adding to Section "E" (Hamilton) thereof the following items, namely;

Hughson	Northerly	Main	Wilson
King William	Easterly	James	John

3. Schedule 13 (Designated Traffic Lanes) of By-law No. 01-215, as amended, is hereby further amended by removing from Section "E" (Hamilton) thereof the following items, namely:

John	30m south of Burlington and Burlington	West	Anytime	Northerly to Westerly
John	30m north of Burlington and Burlington	West	Anytime	Southerly to Easterly and Southerly to Westerly

And by adding to Section "E" (Hamilton) thereof the following items, namely:

Hughson	15 metres south of Wilson to Wilson	West	Anytime	Northerly to Westerly
Hughson	20 metres north of Wilson to Wilson	West	Anytime	Southerly to Westerly and Southerly to Easterly
