(i) Rental Housing Enforcement Pilot/Voluntary Registry Program (PED10049(u)) (City Wide) (Item 8.1)

Kim Coombs, Manager, Licensing and By-law Services, addressed the Rental Housing Sub-Committee with an overview of Report PED10049(u) respecting a Rental Housing Enforcement Pilot/Voluntary Registry Program.

Staff were directed to work along side the Rental Housing Sub-Committee Working Group to gather research on, and incentives for, owners of illegal units.

Staff were directed to examine the Residential Zoning By-law and the feasibility of an amnesty program to meet a new criteria for zoning, with a report back to the Rental Housing Sub-Committee.

Report PED10049(u) respecting a Rental Housing Enforcement Pilot/Voluntary Registry Program, was received.

(f) MOTION (Item 9)

(i) Zoning By-law (Item 9.1)

A. Pathak introduced the following motion:

WHEREAS, the mandate of the Rental Housing Sub-Committee is " to work with interested stakeholders, to assist with the implementation of an approach to enforcement and legalization of appropriate rental housing including, but not limited to, process fees and bylaw regulations"; and

WHEREAS, the Strong Communities Through Affordable Housing Act, 2011 amended various sections of the Planning Act to facilitate the creation of second units by "requiring municipalities to establish official plan policies and zoning by-law provisions allowing second units in detached, semi-detached and row houses, as well as in ancillary structures."

THEREFORE BE IT RESOLVED:

- (a) That staff be directed to compare the *Ontario Building Code* secondary suite requirements to the City of Hamilton's secondary suite requirement and report back to the Rental Housing Sub-Committee, on any differences and rationale for the differences; and
- (b) That staff report back to the Rental Housing Sub-Committee with a timeline for the City of Hamilton to establish an official plan policy and zoning by-law provisions to allow secondary units as set out in the Strong Communities Through Affordable Housing Act, 2011

(ii) Feasibility of Conducting a Pilot Program of Licensing Rental Housing in Wards 1 and 8 (Added Item 9.2)

The motion respecting the Feasibility of Conducting a Pilot Program of Lincensing Rental Housing in Wards 1 and 8 to be TABLED until the next meeting of the Rental Housing Sub-Committee.
