To Authorize the Execution of the Public Transit Infrastructure Fund Phase One (Ontario) Transfer Payment Agreement between the City of Hamilton and Her Majesty the Queen in right of Ontario as represented by the Minister of Transportation for the Province of Ontario to Receive Funding Under the Public Transit Infrastructure Fund

WHEREAS on the 12th day of October, 2016, the Council of the City of Hamilton did approve of Item 4 of General Issues Committee Report 16-023, as amended, and authorized the City of Hamilton to apply to receive funding for projects under the Public Transit Infrastructure Fund;

AND WHEREAS the Ministry of Transportation has approved funding for 14 City of Hamilton projects under the Public Transit Infrastructure Fund listed in Schedule 1 to this By-law;

AND WHEREAS at its meeting on October 12, 2016, the Council of the City of Hamilton also authorized the signing of a Transfer Payment Agreement with Her Majesty the Queen in right of Ontario as represented by the Minister of Transportation to receive funding for the approved projects under the Public Transit Infrastructure Fund;

AND WHEREAS at its meeting on April 26, 2017, the Council of the City of Hamilton authorized the expenditure of \$36,489,204.00 for the projects approved under the Public Transit Infrastructure Fund;

NOW THEREFORE the Council of the City of Hamilton enacts as follows:

- 2. The projects listed in Column 1 of Schedule 1 have been approved by the Minister of Transportation to receive the corresponding funding amount in Column 2 under the Public Transit Infrastructure Fund.
