# 2. Truck Routes – Standardization of Truck Route Signage (PW17050) (City Wide) (Item 5.3)

That Report PW17050 respecting Truck Routes – Standardization of Truck Route Signage, be received.

# 3. Feasibility of determining Out of Town truck traffic using the RHVP and the LINC (PW16084(b)) (City Wide) (Item 5.4)

(a) That Report PW17050 respecting the Feasibility of determining Out of Town truck traffic using the Red Hill Valley Parkway (RHVP) and the Lincoln M. Alexander Parkway (LINC), be received; and,

- (b) That staff be directed to conduct a traffic count study to determine the amount of out of town truck traffic using the RHVP and the LINC at the following four locations: Highway 403 at Sunnyridge Road, the QEW and Fifty Road, the RHVP at Barton Street and the LINC at Golf Links Road; and.
- (c) That the cost of the study, in the amount of \$16,000 (plus HST), be funded from either the Traffic Count Budget or the Red Light Camera Reserve Account (upon a determination by staff of which is the appropriate funding source).

#### 5. Trespassing ATVs (Item 6.1)

- (a) That staff be directed to correspond with Hydro One and Alectra Utilities expressing the concerns of local residents about ATVs trespassing on private property, especially the effect it has on local farmers; and,
- (b) That in the correspondence with Hydro One and Alectra Utilities they be asked to consider taking the steps necessary to prevent ATVs from trespassing on hydro right-of-ways (including erecting barriers/fences) and that staff report back to the Public Works Committee with any response/results from those letters, and:
- (c) That the Mayor correspond with the Chief of the Hamilton Police Service (HPS) to express the concerns that local residents have about ATVs trespassing on private property, especially the effect it has on local farmers, and encouraging the HPS to continue monitoring this situation.

# 6. Proposed Permanent Closure of a Portion of Mountain Brow Road, Hamilton (PW17047/PED17109) (Ward 15) (Item 6.3)

That a portion of Mountain Brow Road, Hamilton, from approximately 400m east of Flanders Drive to 1120m east of Flanders Drive, as shown in Appendix A to PW Report 17-008, be permanently closed and retained, subject to the following conditions:

- (a) That the City Solicitor be authorized and directed to prepare a Bylaw to permanently close the highway;
- (b) That the appropriate By-law be introduced and enacted by Council;
- (c) That the City Solicitor be authorized and directed to register a certified copy of the By-law permanently closing the highway in the proper land registry office, upon confirmation from the Public Works Department that all applicable fees and costs associated with the application have been paid by the applicant;
- (d) That the By-law permanently closing the highway does not take effect until a certified copy of the By-law is registered in the proper land registry office;
- (e) That the Public Works Department publish a notice pursuant of the City's intention to pass the By-law pursuant to City of Hamilton By-law 04-299 being a By-law to Establish Procedures, including the Giving of Notice to the Public.
- 7. Proposed Permanent Closure and Sale of a Public Unassumed Alley Between Sydenham Road, Cross Street, Alma Street and Victoria Street, Dundas (PW17048) (Ward 13) (Item 6.4)
  - (a) That a portion of the north/south public unassumed alleyway between Sydenham Road, Cross Street, Alma Street and Victoria Street, Dundas, as shown in Appendix B to PW Report 17-008 (the Subject Lands), be permanently closed and sold to the owner of 63 Sydenham Road, Dundas subject to the following conditions:
    - (i) That the applicant makes an application to the Ontario Superior Court of Justice, under Section 88 of the Registry Act, R.S.O. 1990, for an order to permanently close the Subject Lands;
    - (ii) That the General Manager, Public Works or his designate sign the appropriate documentation to obtain the order;
    - (iii) That the documentation regarding the application to the Ontario Superior Court of Justice be prepared by the applicant, to the satisfaction of the City Solicitor;
    - (iv) That the applicant deposit a reference plan under the Registry Act and that said plan be prepared by an Ontario Land Surveyor to the satisfaction of the Manager, Geomatics and Corridor Management Section and that the applicant deposit a reproducible copy of said plan with the Manager, Geomatics and Corridor Management Section;

- (b) That provided the application to the Ontario Superior Court of Justice to permanently close the Subject Lands is approved:
  - (i) That the City Solicitor be authorized and directed to prepare the by-law to permanently close the highway;
  - (ii) That the appropriate by-law be introduced and enacted by Council;
  - (iii) That the Real Estate Section of the Planning and Economic Development Department be authorized and directed to sell the closed highway to the owner of 63 Sydenham Road, Dundas, in accordance with By-Law 14-204, Sale of Land Policy By-Law, for a nominal fee;
  - (iv) That the City Solicitor be authorized and directed to register a certified copy of the by-law permanently closing the highway in the proper land registry office, upon confirmation from the Public Works Department that all applicable fees and costs associated with the application have been paid by the applicant;
  - (v) That the by-law permanently closing the highway does not take effect until a certified copy of the by-law is registered in the proper land registry office;
  - (vi) That the Public Works Department publish a notice of the City's intention to pass the by-law pursuant to City of Hamilton By-law 14-204 being a By-law to Establish Procedures, including the Giving of Notice to the Public, Governing the Sale of Land Owned by the City of Hamilton;
  - (vii) That the applicant enter into agreements with any Public Utility requiring easement protection:
  - (viii) That the applicant enter into private agreements with those property owners abutting the Subject Lands, to allow those property owners unobstructed access to their properties over the Subject Lands;
  - (ix) That should the alley be closed and sold, the owner of 63 Sydenham Street be required to obtain retroactive approval of a Heritage Permit for the paving of the alleyway to the satisfaction of the Director of Planning and Chief Planner.

That Report PW16048(a)) respecting the Escarpment Rehabilitation and Strategy Plan, be received, as amended.

- (a) That the extension of an existing easement agreement between the City of Hamilton and Sun Canadian Pipeline Limited ("SCPL") effective October 1, 2014 until and including September 30, 2056 (the "Easement Agreement") substantially on the terms and conditions outlined in Appendix C to PW Report 17-008 be approved, in a form satisfactory to the City Solicitor;
- (b) That the General Manager of Public Works be directed and authorized, on behalf of the City, to approve and execute as appropriate, any and all required consents, permissions and agreements, including the Easement Agreement, necessary to give effect to the Easement Agreement including the relocation of the pipeline as outlined in Appendix C to PW Report 17-008.

# 12. Traffic Island Beautification at Gloucester and Inglewood and Traffic Bumpout Beautification on Aberdeen Avenue (Ward 2) (Item 9.1)

WHEREAS, there is interest from Ward 2 citizens to beautify, with plant material, the intersection of Gloucester and Inglewood (conversion) in Ward 2, and 6 Traffic Bump-outs (perennials) on Aberdeen between Queen St S and Turner Ave and;

WHEREAS, that these locations were included in the Traffic Island Beautification Program Report (PW16094)(City Wide) Item 6.2(a) which was deferred to the 2018 Capital Budget process at the December 9, 2016 GIC and;

WHEREAS, the Ward 2 Councilor proposes to cover the capital expenses from the Ward 2 Area Rating Capital Reserve Account 108052.

#### THEREFORE BE IT RESOLVED:

- (a) That staff be directed to convert the existing concrete median located at Gloucester and Inglewood to an annual floral traffic island;
- (b) That staff be directed to convert the six existing perennial planted traffic bump-outs at Aberdeen between Queen St. S and Turner Ave to annual floral traffic bump-outs;
- (c) That funds for the projects, not exceeding \$18,000, plus a \$5,000 contingency, come from the Ward 2 Area Rating reserve account 108052;
- (d) That annual operational costs of \$1,500 be added to Environmental Services, Horticulture base operating budget starting in 2018.

# 13. Speed Limit Reduction – Queen Street (Amelia to King) (Wards 1 and 2) (Added Item 10.1)

WHEREAS, off peak speeds on Queen Street, at the base of Beckett Hill in Wards 1 and 2, have been recorded at a maximum of speed of 96 km/h; and,

WHEREAS, the bus shelter at the corner of Aberdeen Avenue and Queen Street has been completely obliterated due to high speed traffic collisions two times in the last four years; and,

WHEREAS, similar to the bottom of the Kenilworth Access, there are residential homes all along the east and west sides of Queen Street; and,

WHEREAS, Kenilworth Avenue South has a maximum speed limit of 40km/h from the base of the access north to Main Street; and,

WHEREAS, Traffic Engineering staff do not support the speed limit reduction on Queen Street South (at the base of the Beckett Hill) to 40 km/h and are requesting direction from Council to institute this change;

#### THEREFORE BE IT RESOLVED:

- (a) That staff be directed to take the required steps to reduce the speed limit to 40 km/hour on Queen Street from Amelia Street to King Street; and,
- (b) That funding for signage for the speed limit reduction, as outlined above, be taken from the Red Light Camera Fund at an upwards cost of \$5,000; and,
- (c) That the by-law required to enact the speed limit reduction on Queen Street (between Amelia and King), be prepared.



#### **RECOMMENDATIONS:**

- (a) That the extension of an existing easement agreement between the City of Hamilton and Sun Canadian Pipeline Limited ("SCPL")effective October 1, 2014 until and includingSeptember 30, 2056(the "Easement Agreement") substantially on the terms and conditions outlined in this report be approved, in a form satisfactory to the City Solicitor;
- (b) That the General Manager of Public Works be directed and authorized, on behalf of the City, to approve and execute as appropriate, any and all required consents, permissions and agreements, including the Easement Agreement, necessary to give effect to the Easement Agreement including the relocation of the pipeline as outlined in this report.

#### **EXECUTIVE SUMMARY**

In 2000, the City of Hamilton and the Hamilton Port Authority (the "HPA") entered into a settlement agreement involving the lands known as Piers 6,7 and 8 which included the City's assumption of an existing easement agreement between the SCPL and the HPA that expired on September 30, 2014 and which permitted the SCPL to locate and operate a pipeline transporting liquid hydrocarbons and related products over lands now owned by the City (as indicated in the annotated aerial photograph attached as Appendix A).

Approval of the Easement Agreement will:

 a. provide the SCPL with the certainty of a legally binding easement and license to continue the transportation of hydrocarbons and related products over City

lands to facilitate the delivery of these products to SCPL destinations throughout Southern Ontario;

- b. permit the City to generate revenues in the approximate amount of \$1.15M over the course of the Easement Agreement; and
- c. permit the SCPL to comply with the City's request to relocate a portion of its pipeline at SCPL's cost along and over Discovery Drive and along Guise Street (as outlined in the annotated aerial photographattached as Appendix B) to facilitate the development of the Pier 8 lands.

## Alternatives for Consideration –Not Applicable

#### FINANCIAL - STAFFING - LEGAL IMPLICATIONS

Financial: The City of Hamilton will receive approximately \$1,144,709.40 revenues over the life of the Easement Agreement (42 years – October 1, 2014 to September 30, 2056). First year revenues of \$21,176, Year 42 revenues equal \$41,240). Revenues will be used for park maintenance associated with the West Harbour and will be deposited to account number 46110-444055. Prior to October 1, 2014, revenues associated with the pipeline easement were received by the Port Authority. The Finance Division has reviewed the fees to be paid by the SCPL and is comfortable with the Easement Agreement.

Staffing: There are no staffing implications associated with this Easement Agreement.

Legal:The City's Legal department has been actively involved in negotiating the Easement Agreement.

#### HISTORICAL BACKGROUND

In 2014, the City and the HPA entered into an agreement for the early termination of the 25 year agreement that provided for advancement of the Pier 8 City of Hamilton development plans.

The SCPL pipeline was located within the Pier 8 lands and the pipeline is required to be relocated to allow for the development of the Pier 8 lands. The costs of the relocation of the pipeline are 100% the responsibility of SCPL.

Since the SCPL original easement agreement to relocate the pipeline to facilitate the Pier 8 development plans was at the end of its original term in 2014 a new Easement Agreement is required.

The significant terms and conditions of the new Easement Agreement include:

- 1. Term (approximately 42 years)—from October 1, 2014 to September 30, 2056;
- 2. Fees Payable By SCPL (per linear foot per annum):

- (a) October 1, 2014 until September 30, 2021--Four Dollars (\$4.00);

- (d) October 1, 2031 until September 30, 2036--Five Dollars and Thirty-Two Cents (\$5.32);
- (e) October 1, 2036 until September 30, 2041--Five Dollars and Eighty-Six Cents (\$5.86);
- (f) October 1, 2041 untilSeptember 30, 2046--Six Dollars and Forty-Four Cents (\$6.44);
- (g) October 1, 2046 until September 30, 2051--Seven Dollars and Nine Cents (\$7.09); and
- (h) October 1, 2051 until September 30, 2056--Seven Dollars and Seventy-Nine Cents (\$7.79) per linear foot; and
- 3. Length of Pipeline on City Property currently approximately 5,004 linear feet and increasing to approximately 5,325 linear feet on completion of the pipeline relocation outlined in Appendix B.

The City of Hamilton Cycling Advisory Committee requests that the 13% tariff that is currently imposed on almost all imported bicycles be eliminated.

We understand that originally this duty was imposed to protect our Canadian bicycle manufacturing sector. However, with the exception of niche hand-built bicycles, Canada no longer manufactures bicycles, so the duty benefits no one.

Thus the tariff now only inflates the cost of bicycles; yet cycling is a great component of city mobility and an inexpensive means to improve personal health and our environment, and to reduce pollution and the strain on infrastructure.

We also want to take this opportunity to state the merits of bicycles over electric vehicles (EVs).

The carbon footprint to produce a bicycle (about 240 kg / 530 pounds) is significantly smaller than that to produce an electric vehicle (about 16 times as much). Meanwhile, EVs are significantly tax incentivized (i.e. in Ontario \$6,000 - \$10,000, plus other incentives that can add another \$3000- \$5,000) while bikes (or E-bikes) receive no such benefit.<sup>2</sup>

Affordability is a second merit. EVs are only affordable to the middle and upper classes of society, while bicycles are more affordable to all of society. What a boon a bicycle can be to students, the working poor, and those unable to attain a driver's license (a myriad of health reasons can be mentioned); especially with a motor vehicle's maintenance and insurance requirements.

Third, bicycles require significantly less expensive infrastructure and cause virtually no wear and tear on this transportation infrastructure.

There are many benefits in encouraging active transportation. Improved air quality, improved health for all citizens, improved learning habits for children, and less congestion on streets are good reasons for cities and the Canadian government to encourage citizens to use Active Transportation. For every one less auto on the road, there is a net gain for all society.

Let's help the vulnerable and poor to have that alternative available by making bicycles more affordable; instead of adding financial penalties to bike ownership by imposing a 13% duty. 3 & 4
