The 2016 Strategic Planning Process

The 2016 strategic planning process reconnected HIPC with partners and newcomers across Hamilton to understand how to remain responsive to community needs. The consultations and research commissioned have informed the new HIPC strategy and plan for the successful integration of newcomers to Hamilton and the creation of a welcoming community.

THE STRATEGIC PLANNING PROCESS INCLUDED:

- Consultations with HIPC partners and its five working groups: Housing, Settlement, Employment, Health and Language
- > Engagement with 15 community leaders representing health services, settlement agencies, Police services, Emergency services, HIPC staff, City Council, the Mayor's office, the French Catholic School Board, the post-secondary educational sector and former HIPC members
- > Engagement and consultations with over 70 immigrants from five local neighbourhoods
- > Research commissioned on LIP governance model best practices
- > A full-day strategic planning session with 21 HIPC Council members
- > The creation of three planning committees to bring together community partners to further refine HIPC's priorities
- > Strategic planning day brought HIPC together to review and finalize the 3 year strategic plan and 2017-2018 work plan
- Changes to HIPC governance and new 2017-2020 HIPC Strategic Plan approved by Council in January 2017

- > The highest priority systemic barriers in all dimensions of settlement are addressed
- > Engagement with community partners, newcomers and immigrants to verify gaps, plan priority actions and share knowledge to improve outcomes for newcomers

Key projects identified:

- > Annual newcomer services providers' conference/forum
- Process created for identifying the highest priority issues/gaps and deciding on course of action (i.e. solutions, advocacy, recommendations)

HIPC Governance Highlights

In partnership with Pathways to Prosperity (P2P), HIPC commissioned research on promising practices in local immigration partnerships (LIPs) across Canada. Based on these recommendations and feedback from the Hamilton community, HIPC has implemented several changes to its governance model for 2017-2020. Highlights include:

- > The creation of a permanent seat on HIPC for the Chairs of the Advisory Committee for Immigrants and Refugees. This new seat will strengthen HIPC partnership with this Hamilton citizens' advisory committee and increase community feedback at the strategic planning level.
- A new requirement that a minimum of 3 members of the Council have lived newcomer experience.





HIPC engaged community partners and stakeholders through events, roundtables and conferences resulting in strengthened local, provincial and federal partnerships. HIPC's engagement efforts in the community increased awareness of newcomers' needs and has allowed for organic, innovative and sustainable partnership development.

Employment Focus

As part of HIPC's community consultations, newcomers and immigrants identified employment as the leading barrier to settlement, specifically not being able to secure employment in one's own field of experience. HIPC developed a strategy to showcase immigrant talent in Hamilton and raise awareness among employers on the needs and skills of immigrants.

EMPLOYERS EMBRACING DIVERSITY SERIES

HIPC coordinated a media series titled: "Employers Embracing Diversity" for the Hamilton Spectator, in partnership with Workforce Planning Hamilton and Global Hamilton. The seven articles published in this series created greater awareness of the contributions of immigrants and internationally trained professionals to the Canadian economy and highlighted promising human resource practices.

EMPLOYERS EMBRACING DIVERSITY FORUM


HIPC partnered with Workforce Planning Hamilton, RBC and the Mayor's Advisory Committee on Syrian Newcomers to host the Employers Embracing Diversity Forum on October 27, 2016. The forum showcased local supports and encouraged employers to hire newcomers. ☆IRCC OUTCOME

By facilitating partnerships, coordinating services and sharing information, HIPC identified and addressed some of the employment challenges faced by newcomers. This project highlighted immigrant skills, made resources accessible to employers looking to hire newcomers in Hamilton and helped local employers understand the value of embracing diversity in the workplaces.

Syrian Refugee Resettlement

BACKGROUND

The Government of Canada resettled over 40,801 Syrian new-comers in more than 350 communities across Canada between November 4, 2015 and January 29, 2017. Ontario received 16,956 (42%) of the national total, out of which 1491 (4%) have since called Hamilton home. Of the total Syrian newcomers welcomed in Hamilton, 86% are Government Assisted Refugees (GARs), the third highest total of Syrian GARs welcomed in Ontario. Hamilton received the 4th highest total of all Syrian newcomers welcomed in Ontario – a total amount that is approximately 4 times higher than the average yearly intake of refugees in Hamilton from 2011 to 2015.







With the support of HIPC, the Mayor's Advisory Committee on Syrian Newcomers and its supporting working groups have brought together over 100 community partners to support the resettlement of 1491 Syrian refugee newcomers in Hamilton. The Mayor's Advisory Committee is supported by five Working Groups in the areas of

MEETINGS AND EVENTS

In support of the Syrian Newcomer resettlement process in Hamilton HIPC staff:

- Organized the 'Thank You #HamOnt - One Year Anniversary of Syrians in Hamilton' community engagement event to share information with newcomers and recognize community efforts in welcoming Syrian newcomers to Hamilton. Over 200 newcomers, partners, community organizations and volunteers participated.
- Organized newcomer skating event during the Winterfest festival in partnership with the City of Hamilton's Tourism Office. Refugee newcomer families were able to experience their first skating experience in Hamilton.
- Participated in ongoing provincial and federal conference calls to share information, challenges and best practices related to the settlement of Syrian refugees in Canada.
- Hosted a community consultation meeting with Private Sponsored Refugee (PSRs) groups and Sponsorship Agreement Holders (SAHs) to identify gaps and opportunities.
- Administered the new Employment, Language and Skills Development Working Group.
- Provided support to the Community Supports and Networks Working Group.
- Addressed service gaps and opportunities via participation on the City of Hamilton Staff Working Group on Syrian Newcomers and bi-weekly Syrian Refugee Newcomer and Immigration team meetings.
- Organized a Cultural Competency Workshop for volunteers working with Syrian refugees in Hamilton in

- collaboration with Hamilton Centre for Civic Inclusion (HCCI) and Wesley Urban Ministries.
- > Organized the '#WelcomeRefugees Information Fair' on March 01, 2016 in partnership with MP Filomena Tassi, the City of Hamilton's Mayor's Office, Immigrants Working Centre and Wesley Urban Ministries. The HIPC Settlement Working Group contacted a list of 200 ethno-cultural and faith based organizations in Hamilton and invited them.

RESOURCES AND PUBLIC AWARENESS

- Assisted the City of Hamilton's Recreation department in the creation and distribution of a recreation package in Arabic for Syrian refugee families, which included a free family recreation pass, translated fee assistance application and translated recreation programs in Hamilton.
- Translated and printed HIPC's Newcomer Services Guide and Housing Guide in Arabic with over 1000+ copies distributed to local service providers, institutions, community groups and newcomers.
- Translated the Mayor's welcome message for Syrian newcomers in

- Hamilton.
- Developed and distributed a "Welcome to Hamilton" Settlement Services information card.
- Translated and distributed the City of Hamilton's Canada Day event poster in Arabic.
- Created 100+ Newcomer Resource packages in Arabic and English for city-wide distribution at Ontario Works offices.
- Disseminated all resource guides and tools via the HIPC and the City of Hamilton's websites.
- Highlighted HIPC's resource guides and website as a panelist at the Inform Ontario Education & Networking Symposium.
- Provided support to the development and maintenance of the City's Syrian webpage: www.hamilton.ca/syriannewcomers
- Collected and posted community Syrian refugee events and stories.

PROJECTS IN PROGRESS

- A workshop for language and employment service providers working with newcomers in Hamilton will be organized on April 21, 2017. The workshop will explore innovative ways of working together. Workshop date: April 21, 2017.
- The Syrian Newcomer Resettlement Evaluation is in progress. Completion date: May 2017.



TRCC OUTCOME

HIPC's strong network of partners resulted in strategic community collaborations with the goal of resettling Syrian newcomers in Hamilton. HIPC helped in identifying gaps and opportunities, connected essential stakeholders and engaged newcomers. By adopting a leadership role between the municipality and community partners, HIPC shared information and equipped service providers and newcomers with the resources they needed to facilitate the settlement process. HIPC also engaged with local residents to foster a welcoming environment for newcomers and refugees

Governance and Strategic Planning

Since 2009, HIPC has come a long way in bringing together community leaders and supporting initiatives to help newcomers settle in Hamilton. Building on HIPC's success, the 2016 strategic planning process reconnected with partners and newcomers to understand how HIPC can continue to remain responsive to community needs. The consultations helped HIPC shape new priorities for the successful integration of newcomers to Hamilton and the creation of a welcoming community.

The strategic planning process included:

- Consultations with HIPC partners and five working groups: Housing, Settlement, Employment, Health and Language.
- Engagement with 15 community leaders representing health services, settlement agencies, Police services, Emergency services, HIPC staff, City Council, the Mayor's office, the French Catholic School Board, the post-secondary educational sector and former HIPC members.
- Engagement with immigrants from five local neighbourhoods.
- Research on LIP governance model best practices.
- Full-day strategic planning session with 21 HIPC Council members.

The consultations highlighted the need for HIPC to focus its efforts and resources to advance the following areas: Coordination of Newcomer Services, Communications, Community Engagement, Research and Evaluation. Three Ad Hoc strategic planning committees were established to further develop these priority areas and to identify next steps:

- Communications and Community Engagement,
- Coordination of Services,
- Research and Evaluation

Between April and May of 2016, HIPC disseminated the results of the consultations to Working Group members and transitioned HIPC's five working groups towards membership on one of three new Ad Hoc strategic planning committees and/or membership on one of the working groups created to support the Mayor's Advisory Committee on Syrian newcomers. Several HIPC members chose to be a part of both the strategic planning committees and the Mayor's Advisory working groups which is acknowledged as a considerable commitment of time and effort.

HIPC's three Ad Hoc strategic planning committees developed the committee's Terms of Reference and planned projects aligned with HIPC's vision and strategic priorities. On December 15, 2016, the committees identified cross cutting projects and task teams to support HIPC's vision for 2017-2020.

The strategic planning process resulted in:

- Vision: 'Hamilton welcomes newcomers, celebrates diversity and is a place for everyone to call home.'
- Mission: The Hamilton Immigration Partnership Council coordinates local strategic planning and community based knowledge-sharing to advance the successful settlement and integration of all newcomers to Hamilton
- > Strategic Priorities:
 - Hamilton is a responsive, welcoming and inclusive community
 - Newcomers are supported through strong community partnerships
 - The Hamilton Immigration Partnership Council is a leader in immigration research and knowledge-sharing
- Priority Focus Areas:

 - Inclusivity
 - Transparency

NEXT STEPS

The strategic planning process has resulted in an exciting new strategic direction, priorities and areas of focus for 2017-2020. HIPC's implementation plan will operationalize the strategy through priority projects and actions to bring the HIPC vision to life. HIPC will regularly evaluate its plan and re-evaluate priorities against emerging community needs and immigration trends in order to be responsive and flexible to the Hamilton community and its partners.

Special thanks to the Hamilton Immigration Partnership Council and its community partners who have volunteered their time in support of the council and its subcommittees. Of note, several HIPC members demonstrated exemplary dedication to both the Syrian refugee resettlement project through the Mayor's Advisory Committee on Syrian Newcomers and to the HIPC strategic planning project. Thank you for all that you have done, and continue to do to make Hamilton a welcoming community for newcomers.

RESETTLEMENT OF SYRIAN NEWCOMERS IN HAMILTON:

EVALUATION SUMMARY AND RECOMMENDATIONS







The Mayor's Advisory Committee on Syrian Newcomers



Background

Hamilton is a city that regularly welcomes newcomers and refugees. In the past, the city welcomed refugee influxes from Vietnam, Cambodia, Kosovo and Somalia.

Between November 2015 and April 2017, Canada resettled 44,920 Syrian newcomers in more than 350 communities across the country. Ontario received 19,915 (44.3%) of the national total, out of which 1,710 (3.8%) have since called Hamilton home. The volume of Syrian refugees represented more than four times the number of refugees typically welcomed to Hamilton in a year, thereby creating different kinds of resettlement challenges, opportunities and success stories.

Of the total Syrian newcomers welcomed in Hamilton, 82.2% are Government Assisted Refugees (GARs), the third highest total of Syrian GARs welcomed in Ontario. Hamilton received the 5th highest total of all Syrian newcomers welcomed in Ontario, behind Toronto (8,895), Ottawa-Gatineau (2,435), London (1,915) and Kitchener-Cambridge-Waterloo (1,720).



In Hamilton, Wesley Urban Ministries is the lead agency for GARs, while various private groups, church affiliates, community organizations and other private individuals sponsored PSR and BVOR refugees who came to Hamilton.

Evaluation Overview

This report presents the findings of an evaluation of the resettlement of Syrian newcomers in Hamilton. The evaluation was conducted to assist the Mayor's Office, City of Hamilton and community partners in understanding the collective experience of the Syrian resettlement efforts, what worked and what could be improved for future resettlement initiatives.

1,710 Syrian newcomers arrived in Hamilton from November 2015 to April 2017. Almost 1,000 Syrians arrived in the first several months alone. Partners



characterized the initial period of the influx as overwhelming and challenging. They attributed the challenge largely to the volume of refugees, lack of adequate information and the speed of newcomers' arrival.

In March 2016, it became apparent that Hamilton's Syrian resettlement effort could benefit from a collaborative table involving key sectors with touch points to the resettlement efforts. The key sectors identified were housing, health, language, employment, education and informal community networks. In view of this, the Mayor issued a call to action, bringing together a coalition of community partners for its first meeting in spring of 2016 to form The Mayor's Advisory Committee on Syrian Newcomers.

The Mayor's Advisory Committee on Syrian Newcomers and its five Working Groups, became a collaborative table involving over 100 community partners, private citizens and some Syrian newcomers. The committee worked together to identify, discuss and address key challenges associated with the resettlement work. Now, more than a year into its mandate, the Mayor's Advisory Committee is wrapping up the collaborative table with this evaluation and lessons learned report.



This report draws on feedback gathered from key community partners, private sponsors and Syrian newcomers with respect to their experiences with the Hamilton's Syrian resettlement initiative. Feedback was collected through key informant interviews and focus groups with members of the Mayor's Advisory Committee, its working groups, other services providers and community partners. Interviews were also conducted with eight local private sponsor groups and Sponsorship Agreement Holders. Three focus groups were further conducted involving 50 Syrian newcomers to ensure their voices and experiences were heard and would be used to support potential future response efforts.

Based on the comprehensive engagement process conducted for this evaluation and lessons learned report, eight recommendations have been identified for review and consideration. These recommendations reflect the collective feedback and experiences of Syrian newcomers, community partners and the City of Hamilton staff who supported the initiative in various ways. These recommendations include:

Key Recommendations

Implement the lessons learned from the Syrian resettlement efforts through the Hamilton Immigration Partnership Council (HIPC).

Community partners consider HIPC as an established collaborative table of

immigration and refugee partners in Hamilton involving over 70 key stakeholders. Funded by the Immigration, Refugees and Citizenship Canada (IRCC) and delivered by the City of Hamilton on behalf of IRCC, HIPC is seen as viable and capable of actualizing some of the lessons learned from the Syrian resettlement efforts through its collaborative community tables. However, additional resources may be required for HIPC to be able to fully implement all the lessons learned as its operating budget and mandate are strictly determined by IRCC's Contribution Agreement.



Ensure the Mayor's Office, Hamilton City Council and the City of Hamilton continue to advocate and provide municipal support to the resettlement of refugees and newcomers

Focus groups, interviews and research conducted for this report concluded that municipal governments have strategic roles to play in making their communities welcoming and supportive of newcomers. At the beginning of the Syrian resettlement efforts in Hamilton,

there was increased public and media interest, often with no concrete response from the City, until the Mayor made a motion to create the Mayor's Advisory Committee on Syrian Newcomers. Many saw the Mayor's Advisory Committee as a very effective collaboration that brought all key partners to the table and had the political clout needed to drive a collaborative effort. The City of Hamilton is therefore expected by community stakeholders to continue to play a visible leadership role in creating and supporting a welcoming community for refugees and newcomers.



Develop a comprehensive community settlement and integration plan to support future resettlement initiatives during influx.

The volume, scale and pace of the Syrian resettlement efforts caught many partners off guard. Many partners, institutions and private individuals were not sure what to do or how to help out at the outset of the influx. Understanding critical roles, who was doing what and the support mechanisms at the community level for all expected refugees would have been helpful. In view of this, there is a need to develop a "comprehensive community settlement and integration plan" of some sort to act as a checklist for Hamilton that outlines local roles and responsibilities. The plan will also support better mobilization of partners and resources. Partners recommend this strategic checklist is best suited for HIPC to develop, which should also include a review of best practices locally and from other communities similar to Hamilton.

Support the private sponsorship system in Hamilton.

Roughly 85% of Syrian newcomers in Hamilton came through the Government-Assisted Refugee (GAR) program. However, nearly 15% came through the Privately-

Sponsored Refugee (PSR) program. Private sponsorship is an integral part of the overall settlement and integration system. Unlike GAR which has a dedicated lead agency in Hamilton, the PSR stream is supported by various organizations, religious affiliates, community groups, Settlement Agreement Holders and private citizens. A strategic connection of these partner efforts would be useful. In addition, the GAR and PSR refugee families are also separated from their loved ones overseas. This report recommends more family reunification support and sponsorship advocacy to the federal government.



Enhance newcomers' access to information regarding their rights.

Conversation with various Syrian newcomers revealed the fact that many of them, due to lack of formal English or comprehension of the Canadian system, didn't understand their rights, obligations and protection. Some didn't understand the documents they signed or information passed on to them, even in Arabic. In some cases, some still couldn't understand critical messages, even when the information was translated or interpreted in Arabic due to low literacy level, information volume and the challenges associated with resettling in a new country. This report recommends that more efforts be made to not only translate or interpret documents but also to increase engagement with refugees and obtain

Advocate for more support for organizations working on the front lines of newcomer resettlement and integration in Hamilton.

their feedback regularly with regard to their resettlement experiences, rights, obligations

The newcomers' resettlement experience in Hamilton, similar to other communities, has identified the lack of adequate resources facing many settlement organizations and

supporting agencies. Many of these organizations deal with volume and service requests from clients that have not been matched with commensurate funding from federal and provincial funders. Some even had to lay off staff in the middle of critical need due to lack of adequate funding. This report recommends that the Hamilton City Council, local MPs/MPPs and key community partners continue to advocate with other levels of government and local institutions for additional support for Hamilton's formal and informal organizations that support refugees and newcomers.

and entitlements under the Canadian law.



Improve information coordination among all three levels of government, and among local settlement services providers and community networks.

The federal government has the responsibility and determines quotas of immigrants and refugees coming into Canada through the Immigration, Refugees and Citizenship Canada (IRCC). Traditionally, IRCC deals directly with their community-funded agencies and partners, and largely excluding direct dealings with municipal governments in the process. For the Syrian resettlement effort, information sharing among the federal,

provincial and municipal governments was either not available, too weak or in some cases conflicting. Lack of timely information did not help Hamilton's local resettlement effort in many ways. Some community partners also raise the need for a better information sharing. This report recommends developing an information sharing strategy that supports governments and community partners in creating a better resettlement experiences for refugees in their communities.

Advocate for more support to address longer-term integration challenges. Refugees are supported financially for up to 12 months through government and private sponsors upon arrival. Within this period, they are expected to get a job and integrate successfully. The majority of those who are not able to land a job would end up on Ontario Works (OW) or on the Ontario Disability Support Program (ODSP) from "Month 13". However, critical needs such as affordable housing, language classes, childminding spaces, employment, health services (including mental health) and community supports continue to linger. This report recommends that governments, private enterprises, non-profit organizations and residents continue to provide ongoing support to refugees well beyond the first 12 months.
