  - 3) Economic disadvantage of Transwomen, Transwomen of colour, women that are older or younger; women still are making \$0.36 less on the dollar than their counterparts
  - 4) Physical safety of Transwomen
  - 5) Hamilton Police Services responding appropriately and
  - 6) Gender equity
