- 6.1 Introductions and welcome to the Committee's new members.
- 6.2 Food Strategy Update & Discussion: Sandy Skrzypczyk, Public Health Services, City of Hamilton provided a high level overview of the Food Strategy's Priority Action 1 report to be submitted to the Board of Health in June. The Committee provided feedback on the recommendations and consent to include their

recommendation document as an appendix to the staff report. General consensus was that staff recommendations align well with the Committee's recommendations regarding priority action 1.
